**RESOLUTION APPROVING THE PURCHASE OF PORTABLE
SEWER REHABILITATION EQUIPMENT AND TRAILER FOR USE
BY THE SEWERS DIVISION FROM AP/M PERMAFORM**

WHEREAS, the Fleet Services Division has requested the Finance Department's Procurement Division to issue a purchase order for portable sewer rehabilitation equipment and trailer for use by the Sewers Division of the Department of Public Works; and,

WHEREAS, the portable sewer rehabilitation equipment and trailer is available from AP/M Permaform, 1779 Chessie Lane Ottawa, IL 61350 as the sole area-wide distributor in the amount of \$140,200.00; and,

WHEREAS, Municipal Code section 2-710 (a) provides that the City Council may on a case-by-case basis, upon the recommendation of the City Manager for good cause shown, exempt contracts for the provision of goods and/or services from the competitive procurement requirements of this subdivision, and authorize use of an informal competitive bidding procedure or authorize direct procurement without a competitive process for the procurement of goods and/or services that cost in excess of \$100,000; and,

WHEREAS, the City Manager recommends that the procurement of the above-described equipment be exempted from the competitive bidding requirements for good cause shown, pursuant to Section 2-710(a) of the Municipal Code of the City of Des Moines; and,

WHEREAS, funding is available from 2023-2024 Operating Budget, Equipment Replacement Fund, Page 80.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

1. Good cause is found to exempt the procurement of portable sewer rehabilitation equipment and trailer from the Procurement Ordinance competitive bidding requirements.
2. The purchase of portable sewer rehabilitation equipment and trailer for use by the Sewers Division of the Department of Public Works from AP/M Permaform, in the amount of \$140,200.00 is hereby approved.
3. The City Manager, or his designee, is authorized to take any action or sign any documents necessary to complete this purchase, including to issue a purchase order for the purchase.
