# ORDINANCE NO.

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending 114-361.09, 114-2698, 114-2818, 114-2859, 114-2900, 114-3103, 114-3181, 114-3245, 114-3380, 114-3422, 114-3530, 114-3550, and 114-3625, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by

Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-

361.09, 114-2698, 114-2818, 114-2859, 114-2900, 114-3103, 114-3181, 114-3245, 114-3380,

114-3422, 114-3530, 114-3550, and 114-3625, relating to traffic and vehicle regulations, as

follows:

# Sec. 114-361.09. Parking in alleys.

- (a) No person shall park a vehicle in any alley except for the expeditious loading, unloading and delivery which is incident to the loading and unloading of material or merchandise or passengers. In no event shall any vehicle park in any alley for more than 40 minutes at any one time unless otherwise designated in subsection (b) of this section.
- (b) Any person otherwise in compliance with subsection (a) shall park for no more than ten minutes at any one time in the following described alleys:

   Alley between East Locust Street and East Grand Avenue, on both sides, from East Fourth Street to East Fifth Street.
- $(\underline{bc})$  A person who violates any provision of this section shall pay a fine of \$30.00

# Sec. 114-2698. Southwest Ninth Street--Vine Street to Park Avenue.

Southwest Ninth Street, on both sides, from Vine Street to Elm Street, no parking any time (under Ninth Street Viaduct).

Southwest Ninth Street, on both sides, from Elm Street to Tuttle Street, no stopping or standing (west service road).

Southwest Ninth Street, on both sides, from Vine Street to Tuttle Street, no parking any time (on Ninth Street Viaduct).

Southwest Ninth Street, on the east side, from Tuttle Street to Park Avenue, no parking any time.

Southwest Ninth Street, on the west side, from Tuttle Street to a point <u>290-75</u> feet north <u>south</u> of <u>Loomis-Bell</u> Avenue, no parking any time.

Southwest Ninth Street, on the west side, from Loomis Avenue to a point 290 feet north thereof, school bus loading and unloading 7:00 a.m. to 5:00 p.m. school days.

Southwest Ninth Street, on the west side, from a point 75 feet south of Bell Avenue to a point 120 feet north of Loomis Avenue, bus loading and unloading.

Southwest Ninth Street, on the west side, from <u>a point 120 feet north of</u> Loomis Avenue to Park Avenue, no parking any time.

# Sec. 114-2818. Southwest Twenty-third Street--George Flagg Parkway to Park–<u>Emma</u> Avenue.

Southwest Twenty-third Street, on the west side, from George Flagg Parkway to Sunset Road, no parking any time.

Southwest Twenty-third Street, on the east side, from Bell Avenue to Park Avenue, no parking any time.

Southwest Twenty-third Street, on the west side, from Bell Avenue to a point 100 feet south thereof, no parking any time.

Southwest Twenty-third Street, on the west side, from George Flagg Parkway to Sunset Road, no parking any time.

<u>Southwest Twenty-third Street, on the east side, from Stanton Avenue to a point 85 feet</u> south thereof, no parking any time.

Southwest Twenty-third Street, on the west side, from Stanton Avenue to Emma Avenue, no parking any time.

# Sec. 114-2859. Southwest Twenty-ninth Street-<del>Haines Street<u>Seniomsed Avenue</u> to <u>Watrous-Emma</u> Avenue.</del>

Southwest Twenty-ninth Street, on the west side, from Haines StreetSeniomsed to Edwards Avenue, no parking any time.

Southwest Twenty-ninth Street, on the west side, from Willowmere Drive to a point 50 feet south thereof, no parking any time.

Southwest Twenty-ninth Street, on the east side, from Willowmere Drive to Park Avenue, no parking any time.

Southwest Twenty-ninth Street, on the east side, from a point 160 feet north of Thornton Avenue to Watrous Avenue, no parking any time.

Thirty-seventh Street, on the east side, from John Lynde Road to a point 800 feet south of Grand Avenue, no parking any time.

Thirty-seventh Street, on the east side, from Grand Avenue to a point 800 feet south thereof, no stopping or standing.

Thirty-seventh Street, on the west side, from a point 485 feet south of Grand Avenue to a point 430 feet south thereof, passenger loading and unloading 8:00 a.m. to 5:00 p.m. school days.

Thirty-seventh Street, on the west side, from a point 230 feet south of Grand Avenue to a point 140 feet south thereof, no parking any time.

Thirty-seventh Street, on the west side, from Grand Avenue to a point 100 feet south thereof, no parking any time.

Thirty-seventh Street, on the west side, from Ingersoll Avenue to a point 50 feet north of Woodland Avenue, no parking any time.

Thirty-seventh Street, on the east side, from Ingersoll Avenue to a point 60 feet north thereof, no parking any time.

Thirty-seventh Street, on the east side, from a point 50 feet south of Woodland Avenue to Center Street, no parking any time.

Thirty-seventh Street, on the west side, from Center Street to Rollins Avenue, no parking any time.

Thirty-seventh Street, on the west side, from Crocker Street to a point 100 feet north thereof, no parking any time.

Thirty-seventh Street, on the west side, from Kingman Boulevard to University Avenue, no parking any time.

Thirty-seventh Street, on the east side, from Crocker Street to Kingman Boulevard, no parking any time.

<u>Thirty-seventh Street, on the west side, from a point 50 feet south of Kingman Boulevard</u> to a point 50 feet north of University Avenue, no parking any time.

Thirty-seventh Street, on the east side, from University Avenue to Carpenter Avenue, no parking any time.

Thirty seventh Street, on the west side, from University Avenue to a point 50 feet north thereof, no parking any time.

Thirty-seventh Street, on the west side, from Carpenter Avenue to a point 50 feet south thereof, no parking any time.

Thirty-seventh Street, on the west side, from Franklin Avenue to a point 640 feet north of Holcomb Avenue, no parking any time.

Thirty-seventh Street, on the east side, from Hickman Road to a point 70 feet north thereof, no parking any time.

Thirty-seventh Street, on the east side, from Adams Avenue to a point 300 feet south and any part of the cul-de-sac, no parking any time.

Thirty-seventh Street, on the west side, from Amick Avenue to Douglas Avenue, no parking any time.

Thirty-seventh Street, on the east side, from Douglas Avenue to a point 50 feet south thereof, no parking any time.

# Sec. 114-3103. Corning Avenue--Oxford Street to dead end west of Seventh Street.

Corning Avenue, on the north side, from Oxford Street to Second Avenue, no parking any time.

Corning Avenue, on the north side, from Fifth Avenue to a point 50 feet east thereof, no parking any time.

Corning Avenue, on the south side, from Second Avenue to a point <u>110-30</u> feet west of Seventh Street, no parking any time.

Corning Avenue, on the north side, from Seventh Street to a point 90 feet east thereof, no parking any time.

Corning Avenue, on the north side, from Fifth Avenue to a point 50 feet east thereof, no parking any time.

<u>Corning Avenue, on the south side, from a point 30 feet west of Seventh Street to a point</u> 60 feet west thereof, loading zone.

Corning Avenue, on the north side, from a point 90 feet east of Seventh Street to and including the cul-de-sac west of Seventh Street, no parking any time.

# Sec. 114-3181. Emma Avenue--South Union Street to Southwest Sixteenth-Twenty-ninth Street.

Emma Avenue, on the south side, from South Union Street to Southwest Second Street, no parking any time.

Emma Avenue, on the north side, from Southwest Second Street to a point 50 feet east thereof, no parking any time.

Emma Avenue, on the south side, from Southwest Fifth Street to Southwest Ninth Street, no parking any time.

Emma Avenue, on the north side, from Southwest Fifth Street to a point 50 feet west thereof, no parking any time.

Emma Avenue, on the north side, from Southwest Ninth Street to a point 50 feet east thereof, no parking any time.

Emma Avenue, on the south side, from Southwest Ninth Street to a point 50 feet west thereof, no parking any time.

Emma Avenue, on the north side, from Southwest Ninth Street to Southwest Sixteenth Street, no parking any time.

Emma Avenue, on the south side, from a point 50 feet east of Southwest Fourteenth Street to Southwest Fourteenth Street, no parking any time.

Emma Avenue, on the north side, from Southwest Twenty-third Street to Southwest Twenty-sixth Street, no parking any time.

Emma Avenue, on the south side, from Southwest Twenty-sixth Street to Southwest Twenty-ninth Street, no parking any time.

#### Sec. 114-3245. Grand Avenue--Second Avenue to Third Street.

Grand Avenue, on the south side, from Second Avenue to a point 45 feet west thereof, no parking any time.

Grand Avenue, on the south side, from a point 70 feet west of Second Avenue to a point 40 feet west thereof, is designated a handicapped loading zone, 30-minute limit, and is subject to the same prohibitions as are found in subsection 114-616(a) and section 114-608 of this chapter.

Grand Avenue, on the south side, from a point 110 feet west of Second Avenue to a point 90.45 feet west thereof, loading zone.

# Sec. 114-3380. Kingman Boulevard--Thirty-fifth Street to Forty-second Street.

Kingman Boulevard, on both sides, from Thirty-fifth Street to a point 50 feet west thereof, no parking any time.

Kingman Boulevard, on the south side, from Thirty-seventh Street to a point 60 feet west thereof, no parking any time.

Kingman Boulevard, on the north side, from a point 50 feet east of Thirty-eighth Street to Thirty-eighth Street, no parking any time.

Kingman Boulevard, on the north side, from Forty-second Street to a point 150 feet east thereof, no parking any time.

Kingman Boulevard, on the south side, from Forty-second Street to a point 75 feet east thereof, no parking any time.

#### Sec. 114-3422. Locust Street--Fourth Street to Fifth Avenue.

Locust Street, on the south side, from a point 180 feet west of Fourth Street to Fifth Avenue, no parking any time.

Locust Street, on the north side, from a point 25 feet west of Fourth Street to a point 60 feet east of Fifth Avenue, no parking 7:00 a.m. to 9:00 a.m.

Locust Street, on the north side, from Fourth Street to a point 25 feet west thereof, no parking any time.

Locust Street, on the north side, from a point 25 feet west of Fourth Street to a point 85 feet west thereof, loading zone 9:00 a.m. to 7:00 a.m. the following day.

Locust Street, on the north side, from a point 110 feet west of Fourth Street to a point 80 feet west thereof, taxicab stand 9:00 a.m. to 7:00 a.m. the following day.

Locust Street, on the north side, from Fifth Avenue, to a point 60 feet east thereof, no parking any time.

#### Sec. 114-3530. Oaklyn Drive--Brinkwood Road to Skyline Drive.

Oaklyn Drive, on the west side, from Brinkwood Road to Skyline Drive, no parking any time.

Oaklyn Drive, on the east side, from Lower Beaver Road to a point  $\frac{50-60}{60}$  feet north thereof, no parking any time.

Oaklyn Drive, on the east side, from Skyline Drive to a point 60 feet south thereof, no parking any time.

# Sec. 114-3550. East Park Avenue--South Union Street to dead end east of Southeast Twenty-fifth Street.

East Park Avenue, on both sides, from South Union Street to Southeast Eighth Street, no parking any time.

East Park Avenue, on the north side, from Southeast Eighth Street to Indianola Avenue, no stopping or standing.

East Park Avenue, on the south side, from Southeast Eighth Street to a point 540 feet east thereof, no parking any time.

East Park Avenue, on the south side, from a point 540 feet east of Southeast Eighth Street to a point 115 feet east thereof, bus loading and unloading 7:00 a.m. to 5:00 p.m. school days.

East Park Avenue, on the south side, from a point 655 feet east of Southeast Eighth Street to Indianola Avenue, no parking any time.

East Park Avenue, on the south side, from Indianola Avenue to <u>a point 300 feet west of</u> Southeast Twenty-second Street, no parking any time.

East Park Avenue, on the south side, from a point 210 feet west of Southeast Twentysecond Street to a point 35 feet east thereof, handicap parking.

East Park Avenue, on the south side, from a point 130 feet west of Southeast Twentysecond Street to Southeast Twenty-second Street, no parking anytime.

East Park Avenue, on the north side, from Indianola Avenue to a point 200 feet east of Southeast Fourteenth Street, no parking any time.

East Park Avenue, on the south side, from Southeast Twenty-second Street to the dead end east of Southeast Twenty-fifth Street, no parking any time.

# Sec. 114-3625. Scott Avenue--Southeast First Street to east city limits.

Scott Avenue, on the north side, from Southwest Water Street to Southeast Second Street, no parking any time.

Scott Avenue, on both sides, from Southeast Second Street to a point 225 feet east of Southeast Sixth Street, no parking any time.

Scott Avenue, on the north side from a point 208 feet east of Southeast Tenth Street to a point 22 feet east thereof, handicap parking.

Scott Avenue, on the south side, from Southeast Fifteenth Street to Southeast Fifteenth Court, no parking any time.

Scott Avenue, on the north side, from the dead end east of Southeast Eighteenth Street to, and including, the cul-de-sac west of Southeast Eighteenth Street, no parking any time.

Scott Avenue, on the south side, from the cul-de-sac west of Southeast Eighteenth Street to 75 feet east thereof, no parking any time.

Scott Avenue, on the south side from a point <u>150-780</u> feet west of Southeast Eighteenth Street to a point 200 feet east of Southeast Eighteenth Street, no parking any time.

Scott Avenue, on the north side, from Southeast Twenty-fifth Court to Southeast Twenty-seventh Street, no parking any time.

Scott Avenue, on the north side, from Southeast Twenty-seventh Street to Southeast Twenty-seventh Court, no parking any time.

Scott Avenue, on both sides, from a point 50 feet west of Southeast Thirtieth Street to a point 50 feet east of Southeast Thirtieth Street, no parking any time.

Scott Avenue, on the north side, from a point 50 feet east of Southeast Thirtieth Street to the east city limits, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and

publication as provided by law.
