**HEARING AND ADOPTION OF PROPOSED MUNICIPAL HOUSING AGENCY  
ANNUAL BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2025**

WHEREAS, on April 1, 2024, by Roll Call No. 24-0469, the Municipal Housing Governing Board set the public hearing to consider the Municipal Housing Agency’s proposed annual budget for the fiscal year ending June 30, 2025 for April 15, 2024 at 4:45 p.m. in the Council Chambers in City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa and public notice of such hearing has been published as provided by law in the Des Moines Register; and



NOW, THEREFORE, BE IT RESOLVED by the Municipal Housing Governing Board that:

1. The publication of notice for the hearing is hereby ratified.
2. Upon due consideration of all views and comments presented by residents and taxpayers of the City or the area of operation of the Agency, the public hearing on the Municipal Housing Agency’s proposed annual budget for fiscal year ending June 30, 2025 is hereby closed.
3. The Municipal Housing Agency’s annual budget for the fiscal year ending June 30, 2025, as set forth in the operating budget document on file with the City Clerk is hereby approved and adopted.
4. The Mayor and City Clerk are hereby directed to execute and to certify the Municipal Housing Agency’s budget for the fiscal year ending June 30, 2025 to the Des Moines City Council for incorporation into the City’s fiscal year 2025 budget to be certified to the State of Iowa.
