AN ORDINANCE vacating a portion of the SE $23^{\text {rd }}$ Street right-of-way adjoining 2200 Maury Street.

WHEREAS, all prior requirements of law pertaining to the vacation of public right-of-way have been fully observed; and

WHEREAS, it is desirable that the public right-of-way herein described be vacated;
NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:
Sec. 1. That a portion of the SE $23^{\text {rd }}$ Street right-of-way adjoining 2200 Maury Street, more specifically described as follows, be and is hereby vacated:
