APPROVING THREE LAKES ESTATES PLAT 10 FINAL PLAT AND ACCEPTANCE OF SUBDIVISION BOND

WHEREAS, the final subdivision plat entitled Three Lakes Estates Plat 10, for property located in the vicinity of 6473 Lake Ridge Avenue, to be developed by Timbercrest Homes, LLC, 5721 Merle Hay Road, Johnston, Iowa, John Larson, authorized agent, was submitted to the Development Services Department on December 20, 2022; and,

WHEREAS, the City Plan and Zoning Commission approved the preliminary subdivision plat on August 2, 2001; and,

- 1. It is hereby determined that the subdivision plat identified above conforms to the PlanDSM: Creating Our Tomorrow Plan and the subdivision, with the required installation of public improvements, will not unduly burden public improvements in the area and will provide an appropriate balance of interests between current proprietors, future purchasers and the public interest.
- 2. Subdivision bond number GSH960080 from The Gray Surety, in the amount of \$235,400.00 is hereby accepted and approved as adequate public security for the completion of the required public improvements including public sidewalk within the plat.
- 3. Upon satisfaction of the conditions set forth above, the Mayor and City Clerk are hereby authorized and directed to execute approval on all copies of said subdivision plat as appropriate.
- 4. The City Clerk is hereby directed to provide the approved subdivision plat, a certified copy of this resolution, the attorney's title opinion and the attachments to the plat to the Developer for delivery to the County Recorder for recording by the plat proprietors. The City Clerk is hereby further directed to send a copy of the subdivision plat to the Board of Education, Century Link Communications, Mid-American Energy, Mediacom, Des Moines Water Works, U.S. Post Office Post Master, U.S. Post Office Technical Sales
