ORDINANCE NO. _____

AN ORDINANCE renaming two (2) “Caulder Court” cul-de-sac street segments, located to the west and southeast of Southeast 23rd Street between East Park Avenue to the north and Evergreen Avenue to the south, to “East Caulder Court”.

WHEREAS, the City Council desires to rename two (2) “Caulder Court” cul-de-sac street segments, located to the west and southeast of Southeast 23rd Street between East Park Avenue to the north and Evergreen Avenue to the south, to “East Caulder Court”.

NOW, THEREFORE, Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the two (2) “Caulder Court” cul-de-sac street segments, located to the west and southeast of Southeast 23rd Street between East Park Avenue to the north and Evergreen Avenue to the south are hereby renamed and shall hereafter be known as “East Caulder Court”.

Section 2. That every reference in the Municipal Code of the City of Des Moines, Iowa, 2000, to the two (2) “Caulder Court” cul-de-sac street segments, located to the west and southeast of Southeast 23rd Street between East Park Avenue to the north and Evergreen Avenue to the south shall hereafter be interpreted to refer to East Caulder Court.

Section 3. The City Council finds that this amendment will not affect any official plats in the City of Des Moines, Polk County, Iowa.

Section 4. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.

Section 5. That the City Clerk is hereby authorized and directed to cause certified copies of this ordinance and proof of publication of this ordinance to be properly filed in the office of the County Recorder of the county in which the subject property is located, and to forward copies of this ordinance to the County Auditor and County Assessor of the county in which the subject property is located. The City Clerk is hereby further authorized and directed to forward a copy of

this ordinance to CenturyLink, MidAmerican Energy, MediaCom, Des Moines Water Works, U.S. Post Office – Post Master, U.S. Post Office – Technical Sales and Services, City Engineer, City Land Records, Public Works – Street Department, Public Works – Forestry Division, Fire Department, Police Department – Research and Development Section, City Traffic and Transportation Division, Information Technology Department, and the City Zoning Enforcement Officer.
