APPROVING COMPLETION AND ACCEPTANCE OF THE PAVING, SANITARY SEWER, AND STORM SEWER IMPROVEMENTS SET FORTH IN AND CONSTRUCTED PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, 1930 INDIANOLA AVENUE, BETWEEN SENECA COMPANIES (2148C) AND QUIKTRIP CORPORATION

WHEREAS, on October 23, 2023 under Roll Call No. 23-1412, the City Council approved a private construction contract in the amount of \$459,664.00, between Seneca Companies (2148c), J.C. Risewick, President, 4140 E 14th St., Des Moines, IA, 50313, as Contractor, and QuikTrip Corporation, Chet Cadieux, CEO, 4705 S 129th E Avenue, Tulsa, OK, 74134 as Owner, for construction of Paving, Sanitary Sewer, and Storm Sewer Improvements described as paving, sanitary sewer and storm sewer improvements to serve QuikTrip #0518, located at 1930 Indianola Avenue, as shown on Plan File Numbers: 646-247/254, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.


