**RESOLUTION APPROVING THE PURCHASE OF FIBER INSTALLATION SERVICES FROM COMMONWEALTH ELECTRIC OF THE MIDWEST USING THE STATE OF IOWA AGREEMENT 20450 AND CITY OF DES MOINES SHORT FORM #K23-016**

**WHEREAS**, the Information Technology Department has requested the Finance Department’s Procurement Division to issue a purchase order for the purchase of fiber installation services; and

**WHEREAS**, the Procurement Administrator has determined that the requested fiber installation services have been competitively bid and are available from Commonwealth Electric of the Midwest (1530 2<sup>nd</sup> Avenue, Des Moines, IA 50314, T. Michael Price, President, and CEO) using Omnia Partners/City of Mesa, AZ Contract #2018011-01, as amended (“Omnia Partners Contract”), and using the State of Iowa Contract No. 20450 and the City of Des Moines Short Form Agreement #K23-016; and

**WHEREAS**, Des Moines Municipal Code Section 2-726(k) provides for the procurement of goods and/or services from supply schedules established by the State of Iowa Department of Administrative Services (DAS), without conforming to the competitive bidding requirements of the Procurement Ordinance; and

**WHEREAS**, the fiber installation services are being purchased from Commonwealth Electric of the Midwest, for a total amount of \$108,938.70 the State of Iowa Contract; and

**WHEREAS**, funding for said purchase is available from CIP FY2025, MS001, C051IT99, Miscellaneous Improvements Enhanced City-wide Information and Communication Systems, Page 26.

**NOW, THEREFORE, BE IT RESOLVED**, that the City Council of the City of Des Moines, Iowa, hereby approves the purchase of fiber installation services, in a total amount of \$108,938.70 from Commonwealth Electric of the Midwest per the terms and conditions negotiated by City of Des Moines Short Form Agreement #K23-016, and the above-described State of Iowa Contract.
