## APPROVING DES MOINES MUNICIPAL HOUSING AGENCY REVISED PAYMENT STANDARDS

WHEREAS, the Des Moines Municipal Housing Agency (DMMHA) provides decent, safe and affordable housing to low-income families within Des Moines and Polk County; and

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) provides an annual review of Small Area Fair Market Rents for geographical locations throughout the United States; and

WHEREAS, HUD Published Federal Register Notice FR-6426-N-01, which identifies 41 additional metro areas where Public Housing Agencies (PHAs) will be required to use Small Area Fair Market Rents (SAFMRs) in the Housing Choice Voucher (HCV) Program.

WHEREAS, On October 25, 2023, the DMMHA was notified by the U.S. Department of Housing and Urban Development that the DMMHA was one of the 41 additional metro areas where the PHA would be required to use SAFMRs to establish our payment standards by Zip Code rather than bedroom size effective no later than 90 days after the effective date of the 2025 SAFMRs.

WHEREAS, SAFMRs are calculated at the zip code level rather than the larger metropolitan area level which allows PHAs to establish payment standards that better reflect the local market and help voucher holders access neighborhoods of their choice.

WHEREAS, the DMMHA must set its payment standard between 90% and 110% of the HUD-established Small Area Fair Market Rents; and

WHEREAS, the DMMHA revised its payment standards to be effective January 1, 2025 to be in compliance with the HUD-established SAFMR's; and

WHEREAS, the DMMHA's revised payment standards based on the 2025 SAFMR's are attached to this roll call.

NOW, THEREFORE, BE IT RESOLVED, by the Municipal Housing Governing Board of the City of Des Moines, Iowa, that the adjustment of the Des Moines Municipal Housing Agency payment standards to comply with the HUD-established 2025 Small Area Fair Market Rents, as listed on the attached, is hereby approved, and shall be effective as of January 1, 2025.
