RESOLUTION SCHEDULING HEARING ON THE PROPOSITION TO AUTHORIZE A LEASE AGREEMENT IN THE PRINCIPAL AMOUNT NOT-TO-EXCEED \$1,035,828 FOR THE PURPOSE OF PURCHASING CERTAIN BODY-WORN CAMERA EQUIPMENT AND RELATED SERVICES

WHEREAS, it is deemed necessary and advisable that the City of Des Moines, Iowa ("City") shall enter into an extension of the existing Loan Agreement with Motorola Solutions, Inc. in the principal amount of not to exceed \$1,035,828 (the "Agreement" or "Loan Agreement") as authorized by Iowa Code Sections 364.4 and 384.25 for the purpose of providing for the purchase of certain body-worn camera equipment and related services; and

WHEREAS, the term of the proposed Agreement will not exceed the economic life of the property to be leased; and

WHEREAS, the proposed purchase under the Agreement shall be payable solely out of the City's Local Option Sales & Service Tax (LOSST) and will not cause the total of scheduled annual payments of principal or interest or both principal and interest due from LOSST in any single future fiscal year with respect to all loan agreements in force on the date of Agreement authorization to exceed ten percent of the last certified LOSST amount; and

WHEREAS, a copy of the proposed Agreement is on file in the Office of the City Clerk which provides that the City shall pay an additional three annual payments totaling a increased not-to-exceed \$1,035,828 for the purchase of certain body-won camera equipment and related services; and

WHEREAS, it is in the best interests of the City to extend the agreement for an additional three years to purchase the body-worn camera equipment and related services in conjunction with City operations; and

WHEREAS, before the proposed Agreement may be authorized, it is necessary to comply with the provisions of Iowa Code Sections 364.4 and 384.25 and to publish notice of the proposal and of the time and place of the hearing at which the City Council proposes to take action for the authorization of the Agreement and to receive oral and/or written objections from any resident or property owner of the City to such action.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. The City Council hereby declares its intent, following a public hearing to be held on November 18, 2024, at 5:00 p.m. in the Council Chambers at City Hall, to take action to approve and enter into a Lease Agreement not to exceed \$1,035,828 for the purchase

of certain body-worn camera equipment and related services for use in conjunction with City operations.

PUBLIC NOTICE IS HEREBY GIVEN, that the City Council of the City of Des Moines, Iowa, will hold a public hearing on November 18, 2024 at 5:00 p.m., in the Council Chambers at City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at which meeting the City Council proposes to take additional action for the authorization of a Loan Agreement in the principal amount of not to exceed \$1,035,828 for the purchase of certain body-worn camera equipment and related services for use in conjunction with City operations. The Loan Agreement, on file in the Office of the City Clerk at City Hall, provides that the City shall pay an additional three annual payments totaling an increase not-to-exceed \$1,035,828. The purchase under the Loan Agreement will be payable solely from the City's Local Option Sales & Service Tax (LOSST).

At the above meeting, the City Council shall receive oral or written objections from any resident or property owner of the City to the above action. After all objections have been received and considered, the City Council will at this meeting or at any adjournment thereof, take additional action for the authorization of said Loan Agreement or will abandon the proposal.
