## APPROVAL OF ASSIGNMENT OF ESCROW AGREEMENT BETWEEN THE CITY OF DES MOINES, BANKERS TRUST COMPANY, BLACKBIRD INVESTMENTS, LLC AND 515 WALNUT, LLC

WHEREAS, Bankers Trust Company ("Escrow Agent"), Blackbird Investments, LLC ("Blackbird"), and the City of Des Moines ("City") are parties to a certain Escrow Agreement dated June 4, 2018 (the "Escrow Agreement"), a copy of which is on file in the office of the City Clerk, which secured the services of the Escrow Agent in accordance with a Preliminary Development and Escrow Agreement with Employers Mutual Casualty Company, which was approved the Des Moines City Council on May 21, 2018, by Roll Call No. 18-0925, and related to skywalk connections at 555 Walnut Street; and

WHEREAS, Blackbird is no longer the owner of 555 Walnut Street, and 515 Walnut, LLC is the current owner; and

WHEREAS, the parties have negotiated an Assignment of Escrow Agreement ("Assignment"), which would allow 515 Walnut, LLC to assume all interests and obligations of Blackbird under the terms of the Escrow Agreement, and Blackbird to assign its interests and obligations under Escrow Agreement to 515 Walnut, LLC.

WHEREAS, by executing the Assignment, the City would provide approval and consent of said assignment of interests and obligations from Blackbird to 515 Walnut, LLC.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Assignment on file in the Office of the City Clerk is hereby approved and the Mayor is authorized and directed to execute the Assignment on behalf of the City, and the City Clerk is authorized and directed to attest to the Mayor's signature.
