**APPROVING DES MOINES FIRE DEPARTMENT AND THE AMERICAN NATIONAL RED CROSS  
LICENSED TRAINING PROVIDER AGREEMENT**

**WHEREAS**, the City of Des Moines Fire Department serves as a provider of CPR and Adult/Pediatric Advanced Life Support training required by law for its own personnel; and

**WHEREAS**, a Licensed Training Provider Agreement between The American National Red Cross and the City, setting forth the terms of the licensed training provider program and responsibilities of the parties for a 3-year term through approximately January 2028, is in form on file in the office of the City Clerk; and

**WHEREAS**, pursuant to said Agreement, the Des Moines Fire Department will pay approximately \$4,500.00 every two years to The American National Red Cross for access to and use of its training programs, which amount may increase at least bi-annually;

**WHEREAS**, the Fire Chief recommends approval of said Agreement.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that

1. The Licensed Training Provider Agreement between the City of Des Moines and The American National Red Cross, in form on file in the office of the City Clerk, is hereby approved.
2. The Fire Chief is hereby authorized and directed to execute said Agreement on behalf of the City, and is further directed to administer said Agreement on behalf of the City, including price increases of up to ten percent (10%) bi-annually for payments to be made by the City to The American National Red Cross.
