ORDINANCE NO. _____

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended, by amending Section 114-1, relating to corrections or updates to specific definitions that reflect revisions from prior amendments to the Municipal Code or current processes and operations of the City.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended, by amending Section 114-1, relating to corrections or updates to specific definitions that reflect revisions from prior amendments to the Municipal Code or current processes and operations of the City, as follows:

Sec. 114-1. Definitions.

The following words, terms and phrases, when used in this chapter, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

.....

Parking meter means and includes any ~~mechanical~~ device or multi-space meter not inconsistent with this chapter placed or erected for the regulation of parking by authority of this chapter. Each parking meter space or zone installed shall indicate by proper legend the legal parking time established by the city ~~and when operated shall at all times indicate the balance of legal parking time and, at the expiration of such period, shall indicate illegal or overtime parking.~~

Parking meter district means that area designated by ordinance which shall be subject to this chapter and includes those streets or parts of streets upon which parking meters are installed and in operation. A district may include one or more time and rate zones.

Parking meter space means any space or zone so designated within a parking meter district, ~~adjacent to a parking meter~~. More than one motorcycle may be parked in a parking meter space, provided each such motorcycle is parked with the rear wheel no more than 18 inches from the curb and with the front of such motorcycle facing away from that curb. No motorcycle may share a parking meter space with a motor vehicle having more than two wheels. No motorcycle shall extend beyond the limits of the parking space in violation of section 114-640 of this chapter.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
