# HOLD HEARING FOR APPROVAL OF A LICENSE AGREEMENT WITH CAPITAL CITY PRIDE-DES MOINES FOR USE OF A PORTION OF STREET RIGHT-OF-WAY AT EAST GRAND AVENUE AND EAST 5TH STREET FOR A TEMPORARY ART INSTALLATION

**WHEREAS**, the City of Des Moines ("CITY") is the titleholder of certain street right-of-way ("Licensed Premises") located at East Grand Avenue and East 5<sup>th</sup> Street; and

WHEREAS, Capital City Pride-Des Moines, an Iowa non-profit corporation, wishes to license the Licensed Premises for the purpose of updating the temporary art project consisting of painted sidewalks titled "Pride Sidewalks" and extending the term of the agreement, the 2025 concept has been approved by the Public Art Foundation of Greater Des Moines; and

**WHEREAS**, on May 6, 2024, by Roll Call No. 24-0692 City Council approved a Temporary License Agreement ("License Agreement") with Capital City Pride-Des Moines that allowed for the original art project installation and display, which that License Agreement included a fixed term from May 7, 2024 until September 30, 2025; and

**WHEREAS**, the City has renegotiated a Temporary License Agreement ("Agreement") with Capital City Pride-Des Moines to allow for new installation and extended display of the temporary art project, which Agreement will include, among other terms, the following:

- A fixed 3-year term, on the date that the City signs this document through March 9, 2028.
- The artwork requires annual review and approval by the Public Art Foundation of Greater Des Moines and if the Public Art Foundation does not grant their annual approval, Capital City Pride would be responsible for the removal of the artwork.
- The right of either party to terminate the Agreement prior to the end of the fixed license term, with or without cause, upon thirty (30) days written notice to the other party; and

**WHEREAS**, the City and Capital City Pride propose to terminate the existing License Agreement upon the entry of the renegotiated Agreement; and

WHEREAS, there is no known current or future public need or benefit for the Property proposed to be licensed, and the City will not be inconvenienced by the license of said Property; and

WHEREAS, on February 24, 2025, by Roll Call No. <u>ZS- 0264</u>, it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed license of said street right-of-way be set for hearing on March 10, 2025, at 5:00 p.m., in the City Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa; and

WHEREAS, due notice of said proposal to license the Property was given to all necessary parties as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed license, both

for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, as follows:

- 1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed license of said Property, as described herein, are hereby overruled and the hearing is closed.
- 2. There is no public need or benefit for the street right-of-way proposed to be licensed, and the public would not be inconvenienced by reason of the license of a portion of street right-of way at the intersection of East 5<sup>th</sup> Street and East Grand Avenue, Des Moines, Iowa, legally described as follows, to Capital City Pride-Des Moines, subject to reservation of easements therein, and further subject to all terms and contained in the License Agreement.
