WHEREAS, on February 24, 2024, by Roll Call No. 25-0269, in compliance with the HUD regulations, the City Council set a public hearing for March 24, 2025 at 5:00 p.m. to obtain citizen comments regarding the Consolidated Annual Performance and Evaluation Report (CAPER) for the 2024 Program Year; and

**WHEREAS**, due notice of the public hearing was published in the Des Moines Register on March 6, 2025, and hard copies of the proposed CAPER for the 2024 Program Year were available at all of the Des Moines Public Library branches and a virtual copy was posted on the city's web site, dsm.city, in order to provide citizens with the opportunity to participate in the hearing; and

**WHEREAS**, the public hearing on this date has been opened and those seeking to comment on the CAPER for the 2024 HUD Consolidated Plan Program Year have been afforded the opportunity to do so.

## NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

- 1. All public comments regarding the 2024 HUD Consolidated Plan Program Year have been received and the hearing is hereby closed.
- 2. The Consolidated Annual Performance and Evaluation Report (CAPER) for the 2024 HUD Consolidated Plan Program Year, on file with the City Clerk and by this reference made a part hereof, is hereby approved.
- 3. The City Manager or his designee is hereby authorized and directed to submit the CAPER for the 2024 HUD Consolidated Plan Program Year to the U.S. Department of Housing and Urban Development.
