ORDINANCE NO.	

AN ORDINANCE vacating surface rights in portions of College Avenue right-of-way adjoining 1601 6<sup>th</sup> Avenue.

WHEREAS, all prior requirements of law pertaining to the vacation of public right-of-way have been fully observed; and

WHEREAS, it is desirable that the public right-of-way herein described be vacated;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:

Sec. 1. That the surface rights in portions of College Avenue right-of-way adjoining 1601 6<sup>th</sup> Avenue, more specifically described as follows, be and is hereby vacated:

PART OF THE RIGHT-OF-WAY OF COLLEGE AVENUE BEING PART OF THE SOUTH 30 FEET OF LOT 12 IN BLOCK 3 OF THE OFFICIAL PLAT OF THE SW ¼ OF THE NE ¼ OF SECTION 34, TOWNSHIP 79 NORTH, RANGE 24 WEST, NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:



- Sec. 2. The City of Des Moines hereby reserves an easement upon the property described above for the continued use and maintenance of any utilities now in place, with the right of entry for servicing same.
- Sec. 3. That the City Clerk is hereby authorized and directed to cause certified copies of this ordinance and proof of publication thereof together with proof of publication of the notice of the public hearing on this matter to be properly filed in the office of the Recorder of Polk County, Iowa.
- Sec. 4. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.


