APPROVING A ONE-TIME FISCAL YEAR 2025 FUNDING INCREASE OF UP TO \$70,000 TO THE SHORT FORM AGREEMENT FOR THE REPAIR AND MAINTENANCE OF HEAVY-DUTY TRUCKS AND THE INSTALLED REFUSE COLLECTION EQUIPMENT AND RELATED TELEMATICS SERVICES WITH HOUSBY MACK INC.

WHEREAS, on July 15, 2024, by Roll Call No. 24-0988, the Des Moines City Council approved a short form agreement for the repair and maintenance of heavy-duty trucks and the installed refuse collection equipment and related telematics services with Housby Mack Inc. (4747 NE 14th Street, Des Moines, IA 50313, Kelly Housby, CEO), in the amount of up to \$250,000 annually for one year, renewable for two additional one-year periods ("Agreement"); and

WHEREAS, based on an extensive end-of-year budget review that accounted for the remaining funds, existing invoices for completed repairs and projected invoices that factor in average monthly expenditures, the Fleet Services Division of the City is requesting a one-time funding increase for fiscal year 2025 in an amount not to exceed \$70,000 to allow repairs for the remainder of the fiscal year; and

WHEREAS, funding is available from I010 FN024020 Fleet Service Maintenance Contractual Services, page 88.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that a one-time increase of up to \$70,000 for fiscal year 2025 to the Agreement with Housby Mack Inc. is hereby approved, and the Finance Director is authorized to take all action necessary to effectuate such approval.
