

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended, by amending Sections 114-2082, 114-2864, 114-3391.025, and 114-3659.05, and adding Sections 114-2258.5 and 114-3391.015, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended, by amending Sections 114-2082, 114-2864, 114-3391.025, and 114-3659.05, and adding Sections 114-2258.5 and 114-3391.015, relating to traffic and vehicle regulations, as follows:

Sec. 114-2082. Southeast Thirtieth Street.

Southeast Thirtieth Street, from the south line of Dean Avenue to the south line of East Granger Avenue, stop.

Southeast Thirtieth Street, from the south line of East Army Post Road to the north line of Brockway Drive, stop.

Sec. 114-2258.5. Lake Ridge Avenue.

Lake Ridge Avenue at Brockway Driveway, stop.

Sec. 114-2864. Southeast Thirtieth Street--East Court Avenue to ~~Hart Avenue~~Brockway Drive.

Southeast Thirtieth Street, on both sides, from East Court Avenue to Vandalia Road, no parking any time.

Southeast Thirtieth Street, on the west side, from Hartford Avenue to East Watrous Avenue, no parking any time.

Southeast Thirtieth Street, on the west side, from East Titus Avenue to Easter Lake Drive, no parking any time.

Southeast Thirtieth Street, on the east side, from East Titus Avenue to a point 80 feet south thereof, no parking any time.

Southeast Thirtieth Street, on the west side, from Easter Lake Drive to Hart Avenue, no parking any time.

Southeast Thirtieth Street, on the east side, from East Army Post Road to Brockway Drive, no parking any time.

Sec. 114-3391.015. Lake Hill Drive—Sweetwater Drive to Brockway Drive.

Lake Hill Drive, on the east and south side from Sweetwater Drive to Brockway Drive, no parking any time.

Sec. 114-3391.025. Lake Ridge Avenue—~~Dead end north of East Pine Avenue~~Lake Hill Drive to East Pine Avenue.

Lake Ridge Avenue, on the west side, from ~~the dead end north of East Pine Avenue~~Lake Hill Drive to East Pine Avenue, no parking any time.

Sec. 114-3659.05. Sweetwater Drive—Lake Hill Drive to East Pine Avenue ~~to Dead End~~.

Sweetwater Drive, on the east and south side from Lake Hill Drive to the cul-de-sac north of Three Lakes Parkway, no parking any time.

Sweetwater Drive, on the west side, from ~~dead end north of Fayrdale Drive south the~~ to cul-de-sac north of Three Lakes Parkway to East Pine Avenue and including all of the cul-de-sac, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
