Mayor Boesen, Councilmember Simonson, and Councilmember Voss:

As directed by the Personnel Committee, base annual salaries shall increase 2.50% from fiscal year 2025 for the City Manager, City Attorney and City Clerk, which is consistent with the across-the-board pay increase provided to other Supervisor, Professional and Management employees, if approved and adopted by the Mayor and City Council on Monday, July 14, 2025.

Base annual salaries for the City Council appointees effective June 23, 2025 are:

- City Manager Scott Sanders - \$327,725
- City Attorney Jeff Lester - \$256,776
- City Clerk Laura Baumgartner - \$147,118

The retention bonus for the City Manager and City Attorney shall continue in fiscal year 2026 at 6.5% under the same provisions previously approved by Roll Call 20-1492. Longevity pay for the City Manager shall be increased to 3%.
