**HOLD HEARING FOR VACATION OF SOUTHEAST 14TH COURT RIGHT-OF-WAY
LOCATED NORTH OF EAST EDISON AVENUE**

WHEREAS, on June 9, 2025, by Roll Call No. 25-0822, the City Council of the City of Des Moines voted to receive and file a communication from the Plan and Zoning Commission regarding a City of Des Moines initiated request to vacate approximately 36,000 square feet of Southeast 14th Court right-of-way, which is to the north of East Edison Avenue, as legally described below, subject to the reservation of any necessary easements for all existing utilities in place until such time as they may be abandoned or relocated; and

WHEREAS, there is no known current or future public need or benefit for the right-of-way proposed to be vacated and the City will not be inconvenienced by the vacation of said right-of-way, subject to the reservation of any necessary easements for all existing utilities in place until such time as they may be abandoned or relocated; and

WHEREAS, on June 30, 2025, by Roll Call No. 25-0914, it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed vacation of the right-of-way be set for hearing on July 14, 2025, at 5:00 p.m., in the City Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa; and

WHEREAS, due notice of said proposal to vacate the Southeast 14th Court right-of-way located north of East Edison Avenue, was given to all necessary parties as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed vacation, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed vacation of approximately 36,000 square feet of the Southeast 14th Court right-of-way located north of East Edison Avenue, as described herein, are hereby overruled and the hearing is closed.
2. There is no public need or benefit for the right-of-way proposed to be vacated, and the public would not be inconvenienced by reason of the vacation of said right-of-way, legally described as follows, and said vacation is hereby approved, subject to the reservation of any necessary easements for all existing utilities in place until such time as they may be abandoned or relocated:

ALL OF THE SOUTHEAST 14TH COURT RIGHT OF WAY LYING EAST OF AND
ADJOINING LOTS 13 THROUGH 24 IN BLOCK 8 OF SOUTH RIVERSIDE PARK,
OFFICIAL PLAT, NOW INCLUDED IN AND FORMING A PART OF THE CITY

OF DES MOINES, POLK COUNTY, IOWA, AND CONTAINING
APPROXIMATELY 36,000 SQUARE FEET.

3. Upon final passage of an ordinance vacating said right-of-way and approval by resolution of this City Council, the City Clerk is authorized and directed to forward a certified copy of this resolution and of the affidavit of publication of the notice of this hearing to the Polk County Recorder's Office for the purpose of causing said documents to be recorded.
