**A RESOLUTION APPROVING AMENDMENT TO THE SCHEDULE OF FEES
APPLICABLE TO SPECIAL PARKING PERMIT FINE**

WHEREAS, Chapter 102, Article XVI of the Des Moines Municipal Code authorizes the issuance of street use event permits and Municipal Code Section 114-361.19 authorizes the issuance of special parking permits in conjunction with a street use event permit and the Code section provides that a fine for violating the Municipal Code Section 114-361.19 or special parking permit terms shall be in the amount set in the Schedule of Fees adopted by the City Council by resolution; and

WHEREAS, an amendment to the Schedule of Fees amending the fine-related violation of Municipal Code Section 114-361.19(i) has been prepared for Council consideration and it is recommended for adoption, which amendment is appended hereto and is now on file in the Office of the City Clerk.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the amendment to the Schedule of Fees appended hereto is hereby approved and adopted.

BE IT FURTHER RESOLVED that the City Clerk is hereby authorized and directed to incorporate said amendment to the Schedule of Fees, and to maintain said Schedule of Fees, as amended, on file in the Office of the City Clerk for a public reference.
