**ORDERING CONSTRUCTION OF
NAHAS AQUATIC CENTER EQUIPMENT REPLACEMENT
AND FIXING A DATE FOR RECEIVING OF BIDS ON SEPTEMBER 2, 2025
AND PUBLIC HEARING ON SEPTEMBER 29, 2025
ENGINEER'S ESTIMATE IS \$255,000**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached communication recommending construction of the following improvement and the method of financing; and also including the recommendation of the Des Moines City Engineer, as the Engineer, submitting plans, specifications, form of contract documents, and Engineer's estimate of cost for the construction of the following improvement:

Nahas Aquatic Center Equipment Replacement, Activity ID 112025006

The Nahas Aquatic Center Equipment Replacement project includes the removal of four turbine pumps, plunge pool sand filter, plumbing piping and valves, electrical equipment, and installation of a new filter, four new in-line pumps, plumbing piping and valves, and electrical equipment for a functioning pool equipment system, all in accordance with the contract documents including Plan File No. 671-053/066, located at Nahas Aquatic Center, 1101 Porter Avenue, Des Moines, Iowa, and other locations directed by the Des Moines City Engineer

be and the same are hereby approved and accepted. The estimated construction cost for said improvement is \$255,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.

BE IT FURTHER RESOLVED: That this Council hereby determines that it is necessary and advisable to construct said improvement in the manner set forth in the plans, specifications, and form of contract documents submitted by the Engineer; and that payment for the cost of said improvement shall be paid from the funding source identified below.

BE IT FURTHER RESOLVED: That proposals will be received by the City of Des Moines, at the office of the Des Moines City Clerk until 11:00 a.m. on September 2, 2025, for the construction of said improvement, and the taking of bids in the manner required by law. Proposals received will be opened at a public meeting presided over by the Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, at 11:00 a.m. on September 2, 2025, after which the bids together with a bid tabulation and recommendation of the Engineer will be presented to the City Council at the below-described public hearing for action thereon.

BE IT FURTHER RESOLVED: That a public hearing on said plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be held in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, at 5:00 p.m. on September 29, 2025, at which time this Council will consider any objections offered thereto or to the making of said improvement.
