ROLL CALL SCHEDULING HEARING ON THE PROPOSITION TO AUTHORIZE A LOAN AGREEMENT IN THE PRINCIPAL AMOUNT NOT-TO-EXCEED \$1,091,997.95, FOR THE PURPOSE OF PURCHASING CERTAIN TASER CERTIFICATION BUNDLE EQUIPMENT AND MATERIALS

WHEREAS, it is necessary and advisable that the City of Des Moines, Iowa ("City") shall enter into a Loan Agreement with Axon Enterprise, Inc. in the principal amount of not to exceed \$1,091,997.95 (the "Agreement" or "Loan Agreement") as authorized by Iowa Code Sections 384.24A and 384.25 for the purpose of providing funds for the purchase of certain taser certification bundle equipment and materials; and

WHEREAS, the proposed purchase under the Agreement shall be payable solely out of the City's general fund and will not cause the total of scheduled annual payments of principal or interest or both principal and interest due from the general fund in any single future fiscal year with respect to all loan agreements in force on the date of Agreement authorization to exceed ten percent of the last certified general fund budget amount; and

WHEREAS, a copy of the proposed Agreement is on file in the Office of the City Clerk which provides that the City shall pay five annual payments totaling a principal not-to-exceed \$1,091,997.95for the purchase of certain taser certification bundle equipment and materials; and

WHEREAS, it is in the best interests of the City to purchase the taser certification bundle equipment and materials in conjunction with City operations; and

WHEREAS, before the proposed Agreement may be authorized, it is necessary to comply with the provisions of Iowa Code Sections 384.24A and 384.25 and to publish notice of the proposal and of the time and place of the hearing at which the City Council proposes to take action for the authorization of the Agreement and to receive oral or written objections from any resident or property owner of the City to such action.

RESOLUTION SCHEDULING HEARING ON THE PROPOSITION TO AUTHORIZE A LEASE AGREEMENT BETWEEN THE CITY OF DES MOINES AND E.O. JOHNSON COMPANY, INC. FOR THE LEASE OF MULTI-FUNCTION DEVICES (PRINTER, COPIER, SCANNER AND FACSIMILE) FOR USE IN CITY OPERATIONS FOR A TWO-YEAR PERIOD, IN A TOTAL LEASE AMOUNT NOT TO EXCEED \$450,000.00, AND PROVIDING FOR PUBLICATION OF NOTICE THEREOF

WHEREAS, it is deemed necessary and advisable that the City of Des Moines, Iowa, should enter into a lease agreement for the lease of multi-function devices (printer, copier, scanner and facsimile) for use in City operations for a two-year period, in a total lease amount not to exceed \$450,000.00 to be paid in 24 monthly installments during the two-year term (the "Lease Agreement"), as authorized by Sections 364.4, 384.25, and 384.83 of the Code of Iowa; and

WHEREAS, the term of the proposed Lease Agreement will not exceed the economic life of the personal property to be leased; and

WHEREAS, the Lease Agreement shall be payable solely and only out of the City's general fund and various enterprise funds of the City of Des Moines, and will not cause the total annual lease or lease payments due from the general fund in any single future fiscal year for all lease contracts currently in force to exceed ten percent of the last certified general fund budget amount; and

WHEREAS, the Information Technology Department and Finance Department, Procurement Division, are negotiating the terms of the Lease Agreement which provides that the City shall pay 24 monthly lease payments during the two-year term in a total lease amount not to exceed \$450,000.00, which Lease Agreement shall be placed on file in the Office of the City Clerk prior to the Council hearing; and

WHEREAS, before the proposed Lease Agreement may be authorized, it is necessary to comply with the provisions of the Code of Iowa Sections 362.4, 384.25, and 384.83, and to publish a notice of the proposal and of the time and place of the meeting at which the City Council proposes to take action for the authorization of the Lease Agreement and to receive oral and/or written objections from any resident or property owner of the City to such action.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, that:

- 1. That the City Council hereby declares its intent, following a public hearing to be held on September 29, 2025 at 5:00 p.m. in the Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, to take action to approve and enter into a Lease Agreement with E.O. Johnson Company, Inc. in the total lease amount not to exceed \$450,000.00, for leasing of multi-function devices (printer, copier, scanner and facsimile) for use in City operations for a two-year period, to be paid in 24 monthly payments.
- 2. That the Clerk is hereby directed to cause a publication to be made of a notice of said hearing and intent to take action to approve and enter into the Lease Agreement in a legal newspaper, printed wholly in the English language, not less than four days nor more than 20 days before the date of
