## SET HEARING FOR VACATION OF THE EAST/WEST ALLEY RIGHT-OF-WAY LOCATED IN THE VICINITY OF 232 EAST 16<sup>TH</sup> COURT AND CONVEYANCE TO LINETTE QUINTANILLA FOR \$200.00

WHEREAS, on August 4, 2025, by Roll Call No. 25-1042, the City Council of the City of Des Moines, Iowa voted to receive and file the recommendation from the City Plan and Zoning Commission that the east/west alley right-of-way in the vicinity of 232 East 16<sup>th</sup> Court, which is within the block bounded by East 16<sup>th</sup> Court and a north/south alleyway between Dean Avenue and East Court Avenue ("City Right-of-Way"), hereinafter more fully described, be vacated, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated at no cost to the City; and

**WHEREAS,** Linette Quintanilla, owner of 232 East 16<sup>th</sup> Court, has offered to the City of Des Moines ("City") the purchase price of \$200.00 for the vacation and purchase of the portion of alley right-of-way adjoining their property at 232 East 16<sup>th</sup> Court for assemblage with their adjoining property, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated, which price reflects the fair market value of the City Property as determined by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need for the City Right-of-Way proposed to be vacated and sold, and the City will not be inconvenienced by the vacation and sale of said alley right-of-way.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that:

1. The City Council of the City of Des Moines, Iowa, shall consider adoption of an ordinance permanently vacating the east/west alley right-of-way located in the vicinity of 232 East 16<sup>th</sup> Court, legally described as follows, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned of relocated at no cost to the City:
