ORDERING CONSTRUCTION OF 2026 CITYWIDE TRAFFIC CALMING IMPROVEMENTS AND FIXING A DATE FOR RECEIVING OF BIDS ON NOVEMBER 25, 2025 AND PUBLIC HEARING ON DECEMBER 22, 2025 ENGINEER'S ESTIMATE IS \$340,000

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached communication recommending construction of the following improvement and the method of financing; and also including the recommendation of the Des Moines City Engineer, as the Engineer, submitting plans, specifications, form of contract documents, and Engineer's estimate of cost for the construction of the following improvement:

2026 Citywide Traffic Calming Improvements, Activity ID 042025005

The improvement includes Hot Mix Asphalt (HMA) paving, milling, Portland Concrete Cement (PCC) sidewalks, PCC curb and gutter, crosswalks, earthwork, storm sewer, intakes, pavement markings, traffic control, traffic signs, and surface restoration, all in accordance with the contract documents including Plan File No. 676-323/376, located at the following locations and other locations as directed by the City Engineer within the City of Des Moines, Iowa:

Cottage Grove Avenue between 31st Street and 42nd Street
Williams Street / East 42nd Street between East University Avenue and Easton Boulevard
Hull Avenue between 2nd Avenue and North Union Street
Center Street between 28th Street and 29th Street
Hull Avenue between East 14th Street and Dixon Street
East Douglas Avenue between Lay Street and East 26th Street
Southwest 14th Street between Geil Avenue and Johnson Street
23rd Street between Washington Avenue and Lincoln Avenue
East Washington Avenue between East 14th Street and Wayne Street
St. Johns Road at 35th Street
University Avenue at Glendale Cemetery

Ray Drive, Des Moines, Iowa, at 5:00 p.m. on December 22, 2025, at which time this Council will consider any objections offered thereto or to the making of said improvement.

BE IT FURTHER RESOLVED: That an appropriate Notice to Bidders for said improvement be posted, and Notice of Public Hearing for said improvement be published in the Des Moines Register, all as provided and directed by Chapter 26 and/or 314, Code of Iowa.
