Pursuant to Section 2(b) of the Accelerated Levee System Evaluation Agreement (Agreement) between the Department of the Army and the City of Des Moines, dated July 24, 2023, the Rock Island District (District) is requesting \$139,615.06 for the sponsor's cash contribution to the 100% share of all costs associated with the expanded Levee System Evaluation. The expanded Levee System Evaluation will include a levee accreditation recommendation.

In a letter dated July 27, 2023, the District requested \$194,864.00 for the expanded Levee System Evaluation, which the City of Des Moines subsequently provided. The District has determined that additional funds are required from the City of Des Moines to meet the Non-Federal Interest's share of costs. Additional funds are required due to the expanded scope of work, which includes additional hydraulic modeling, background preparation for assessing probabilities of two semi-quantitative and one quantitative failure modes, and associated report writing and reviews.

Furthermore, additional funds will be required to complete the post-construction addendum to the Semi-Qualitative Risk Assessment. This future work may be eligible for a federal cost share. At that time, the District will provide the City with written notice in accordance with Section 2(b) of the Agreement.
