WHEREAS, 515 Tower LLC ("515 Tower") is the owner of certain real property located at 515 Walnut within the City of Des Moines and is in the process of constructing certain improvements to that real property pursuant to the following agreements between 515 Tower (as successor in interest to Blackbird Investments, LLC and 515 Walnut LLC) and the City:

1. Escrow Agreement dated June 4, 2018;
