APPROVING THE PURCHASE OF ONE REPLACEMENT LABRIE REAR LOAD SOLID WASTE TRUCK FOR USE IN THE SANITATION DIVISION OF THE PUBLIC WORKS DEPARTMENT AND APPROVING USE OF SOURCEWELL CONTRACT NUMBER 110223-LEG

WHEREAS, the Labrie rear load solid waste truck is available utilizing Sourcewell Contract No. 110223-LEG from Kilburg Equipment (431 West Grant Street, Preston, IA 52069; Jesse Kilburg, Owner) in the amount of \$277,096.40; and,

WHEREAS, the funding source will be Fiscal Year (FY) 2025-2026 Recommended Operating Budget, Page 78, Equipment Replacement Fund.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

- 1. Purchase of one replacement Labrie rear load solid waste truck utilizing Sourcewell Contract No. 110223-LEG from Kilburg Equipment (431 West Grant Street, Preston, IA 52069; Jesse Kilburg, Owner) in the amount of \$277,096.40 is hereby approved for use for use in the Sanitation Division of the Public Works Department.
- 2. To the extent determined necessary by the Legal Department and the Finance Department, the Finance Department is hereby authorized and directed to proceed with negotiation of a Short Form Agreement or similar agreement between the City and Murphy Tractor and Equipment is authorized and directed to execute said Agreement on behalf of the City following approval as to form by the Legal Department.
