## APPROVING CAPITAL CONTRIBUTION AGREEMENT BETWEEN THE CITY OF DES MOINES AND 6<sup>TH</sup> AVENUE CORRIDOR, INC. FOR GEOGRAPHIC-SPECIFIC SMALL BUSINESS IMPACT LOAN FUNDING

WHEREAS, the City Council previously established the Small Business Impact Loan Program to promote investment in existing commercial buildings and support the growth and expansion of small businesses within the City of Des Moines, particularly those that face barriers in accessing traditional financing sources; and

WHEREAS, the program is administered by the City's Office of Economic Development and provides short-term, low-interest loans to small businesses pursuant to Iowa Code Chapter 15A and the approved program policy on file in the Office of the City Clerk; and

**WHEREAS,** 6<sup>th</sup> Avenue Corridor, Inc. is a recognized Main Street Iowa organization dedicated to equitable development, supporting local businesses, and advancing neighborhood revitalization along 6<sup>th</sup> Avenue from Interstate 235 to the Des Moines River; and

**WHEREAS**, 6<sup>th</sup> Avenue Corridor, Inc. has received a charitable contribution of \$32,500 from the Wells Fargo Foundation to support small business development projects within the 6<sup>th</sup> Avenue Corridor geography and wishes for the City to administer those funds under the Small Business Impact Loan Program; and

**WHEREAS**, under the Capital Contribution Agreement between the City of Des Moines and 6<sup>th</sup> Avenue Corridor, Inc., the funds will be used exclusively to provide Small Business Impact Loan assistance to businesses located within the 6<sup>th</sup> Avenue Corridor geography; and

**WHEREAS,** the funds contributed by 6<sup>th</sup> Avenue Corridor, Inc. will be recorded separately on the general ledger at the City, with repayments revolving back into that allocation on the general ledger for future use in the Corridor; and

**WHEREAS**, a separate application for loans within the  $6^{th}$  Avenue Corridor will be created and the  $6^{th}$  Avenue Corridor, Inc. will be recognized on the City's website and associated program materials; and

**WHEREAS**, representatives from the 6<sup>th</sup> Avenue Corridor will have the opportunity to attend Loan Review Committee meetings related to applications with the 6<sup>th</sup> Avenue Corridor geography, while final loan decisions remain solely at the discretion of the City; and

WHEREAS, City staff recommends approval of the Capital Contribution Agreement to facilitate efficient, transparent, and equitable administration of the funds in accordance with the Small Business Impact Loan Program's purpose and policy;

	5.	The City Manager is authorized and directed to execute Small Business Impact Loan Program project contracts funded via this Capital Contribution Agreement, agreements for applicants and scoring committee members, and otherwise administer the Program.
