**APPROVING AND AUTHORIZING THE EXECUTION OF
IOWA DEPARTMENT OF TRANSPORTATION (IDOT) ADDENDUM FOR THE
CENTRAL PLACE TRAIL PHASE II PROJECT**

WHEREAS, the City of Des Moines Parks and Recreation Department desires to construct a new multi-use trail section along the west bank of the Des Moines River and City right-of-way between the intersection of 2nd Avenue and Franklin Avenue and the intersection of the Inter-Urban and Trestle to Trestle multi-use trails as part of the Central Place Trail Phase II project ("Project"); and

WHEREAS, on May 5, 2025, by Roll Call No. 25-0636, the City Council approved the execution of Iowa Department of Transportation (IDOT) Agreement No. 25-TAP-120 providing funding in the amount of \$1,300,000 in Transportation Alternative Program (TAP) funding and \$300,000 in federal Recreational Trails Program (RTP) funding for the Project; and

WHEREAS, the IDOT has issued Addendum No. 1-25-TAP-120-A to update the project description to match the IDOT 2026 Statewide Transportation Improvement Program (STIP) project description and location.

NOW, THEREFORE, BE, AND HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That Addendum No. 1-25-TAP-120-A between the City of Des Moines and the Iowa Department of Transportation for the Central Place Trail Phase II project, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content.
2. That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said Agreement for and on behalf of the City of Des Moines, Iowa.
