ORDINANCE NO. _____

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Section 74-180, relating to community recreation center building admissions and rentals.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Section 74-180, relating to community recreation center building admissions and rentals, as follows:

Sec. 74-180. Community recreation center building admissions and rentals.

(a) Community recreation center building admission fees shall be as follows:

Admission Fee	<u>Ages Under 19</u>	Ages 19 to 59	Ages <u>Under 19 and Over 59</u>
Daily entry fee per person	<u>\$0.00</u>	\$2.00	\$1.00
Monthly pass per person	<u>\$0.00</u>	\$24.00	\$12.00
Annual pass per person	<u>\$0.00</u>	\$150.00	\$100.00

(b) Community recreation center building rental fees shall be as follows:

Rental Fees	Per Hour During Regular Operating Hours (2-hour minimum)	Per Hour During Holidays and Non Operating Hours (2-hour minimum)
Rental by governmental, public school and recognized Neighborhood Associations	No charge	No charge
Rental for exclusive use and public admissions where no fee or admission is charged and nothing is sold:		
Small meeting room	\$20.00	\$35.00
Multipurpose room	\$35.00	\$65.00
Gymnasium	\$35.00	<u>\$65.00</u>

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
