**RESOLUTION APPROVING URBAN RENEWAL DEVELOPMENT AGREEMENT  
WITH JDS REAL ESTATE INVESTMENTS, LLC FOR THE HISTORIC  
REHABILITATION AND REDEVELOPMENT OF THE EXISTING 3-STORY OFFICE  
BUILDING AT 108 3<sup>RD</sup> STREET**

**WHEREAS**, JDS Real Estate Investments, LLC, (108 3<sup>rd</sup> Street, Des Moines, IA 50309) (“Developer”), represented by Jeff Stanborough of JDS Real Estate Investments, LLC, Member Manager, proposes to undertake a historic rehabilitation project; and

**WHEREAS**, the project is a historically-compatible rehabilitation and restoration of the existing 3-story, approximately 33,540 square foot vacant office building located at 108 3<sup>rd</sup> Street into commercial office space (“Project”); and

**WHEREAS**, on or about September 8, 2025, by Roll Call No. 25-1220, the City Council approved preliminary terms, which provides for tax increment financing (TIF) to respond to a construction financing gap on the Project, as presented by the development team and vetted by city staff and authorized City staff to negotiate final terms of an Urban Renewal Development Agreement; and

**WHEREAS**, pursuant to the authority and direction of Roll Call No. 25-1220, the City’s Office of Economic Development has negotiated an Urban Renewal Development Agreement with the Developer, all as more specifically described in the accompanying Council Communication, which provides for tax increment financing (TIF) to respond to a construction financing gap on the project, as presented by the development team and vetted by city staff; and

**WHEREAS**, under the terms of the Development Agreement, the project will receive project-generated TIF grant capped at a maximum value of \$1,300,000.00 in project-generated tax increment on a net-present-value basis {NPV} (at a 4.5% discount rate) based on the following schedule: (95%) in years one (1) through five (5), eighty-five percent (85%) in years six (6) through ten (10), and seventy-five percent (75%) in years eleven (11) through fifteen (15) of the Project TIF for a total of fifteen (15) years; and

**WHEREAS**, at a meeting on October 21, 2025, the Urban Design Review Board voted 6-0 to recommend approval of the final design and financial assistance as set forth above and in the Development Agreement; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that:

1. The City Council hereby makes the following findings in support of the proposed Development Agreement with JDS Real Estate Investments, LLC (“Developer”):

- a. The fulfillment of Developer's obligations under the Development Agreement to redevelop the Project further the goals and objectives of the Metro Center Urban Renewal Plan by generating the following public gains and benefits:
    - i. it will advance the improvement and redevelopment of the Project Area in accordance with the Urban Renewal Plan;
    - ii. it will protect the health, safety, and general welfare of City residents;
    - iii. it will maintain and expand taxable property values;
    - iv. it will establish conditions which attract further new investments and prevent the recurrence or spread of blight and blighting conditions to the surrounding area; and
    - v. it will further the City's efforts to retain and create job opportunities within the Project Area and surrounding area which might otherwise be lost.
  - b. The economic development incentives for the development of the Project are provided by the City pursuant to the Urban Renewal Law and Chapter 15A of the Code of Iowa, and Developer's obligations under the Development Agreement to construct the Project will generate the public gains and benefits stated above in subsection (a).
  - c. The construction of the Project is a speculative venture and the construction and resulting benefits would not occur without the economic incentives provided by the Development Agreement.
  - d. The development of the Project pursuant to the Development Agreement, and the fulfillment generally of the Agreement, are in the vital and best interests of City and the health, safety, morals, and welfare of its residents, and in accord with the public purposes and provisions of the applicable state and local laws and requirements under which the Project has been undertaken, and warrant the provision of the economic assistance set forth in the Agreement.
2. The Urban Renewal Development Agreement between the City and JDS Real Estate Investments, LLC and the Conceptual Development Plan attached thereto, both as on file in the office of the City Clerk, are hereby approved, and the Mayor

- and City Clerk are hereby authorized and directed to execute and attest to, respectively, the Agreement on behalf of the City of Des Moines.
3. As soon as reasonably possible following execution by the Mayor and attestation by the City Clerk, the City Clerk is directed to submit a copy of the fully executed Development Agreement to the Finance Department to determine whether disclosure or filing is required for Electronic Municipal Market Access.
  4. Upon requisition by the Office of Economic Development, the Finance Department shall advance the installments on the Economic Development Assistance pursuant to Article 4 of the Development Agreement.
  5. The Department Services Director or designee(s) are hereby authorized and directed to administer the Development Agreement on behalf of the City, and to monitor compliance by the Developer with the terms and conditions of the Agreement. The Department Services Director is further directed to forward to City Council all matters and documents that require City Council review and approval in accordance with the Agreement.
