APPROVING FIRST AMENDMENT TO THE 28E AGREEMENT WITH THE IOWA DEPARTMENT OF AGRICULTURE AND LAND STEWARDSHIP - DIVISION OF SOIL CONSERVATION AND WATER QUALITY, POLK COUNTY, AND DES MOINES WATER WORKS TO PROVIDE FUNDING AND MANAGEMENT FOR THE CENTRAL IOWA COVER CROP SEEDER PROJECT

WHEREAS, the Iowa Department of Agriculture and Land Stewardship - Division of Soil Conservation and Water Quality (hereinafter "DIVISION"); Polk County, Iowa (hereinafter "COUNTY"); the City of Des Moines, Iowa (hereinafter "City"); and Des Moines Water Works (hereinafter "DMWW") entered into a 28E Agreement between the Iowa Department of Agriculture and Land Stewardship – Division of Soil Conservation and Water Quality; Polk County, Iowa; the City of Des Moines, Iowa; and Des Moines Water Works for the Central Iowa Cover Crop Seeder Project, dated January 21, 2022, provide initial funding and define management of the Central Iowa Cover Crop Seeder Project (hereinafter "Agreement"); and

WHEREAS, on December 20, 2021, by Roll Call No. 21-1939, the City Council approved the Agreement between the DIVISION; COUNTY; City; and DMWW, to provide initial funding and define management of the Central Iowa Cover Crop Seeder Project for the period of January 1, 2022 through December 31, 2025; and

WHEREAS, the DIVISION; COUNTY; City; and DMWW desire to amend the Agreement with respect to the termination date and extend such for one (1) additional year to December 31, 2026, with no changes in the originally defined funding or management, retroactive to January 1, 2026; and

WHEREAS, staff from DIVISION; COUNTY; City; and DMWW have negotiated a First Amendment to the Agreement, a copy of which is on file in the City Clerk's Office, which is enforceable for the term of the Agreement until December 31, 2026, retroactive to January 1, 2026.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the First Amendment to the 28E Agreement between the Iowa Department of Agriculture and Land Stewardship – Division of Soil Conservation and Water Quality; Polk County, Iowa; the City of Des Moines, Iowa; and Des Moines Water Works for the Central Iowa Cover Crop Seeder Project for the period through December 31, 2026, retroactive to January 1, 2026, be and is hereby approved, and the Mayor is hereby authorized to execute such First Amendment on behalf of the City and the City Clerk is directed to attest to her signature, as amended.
