**HEARING AND ADOPTION OF AMENDED MUNICIPAL HOUSING AGENCY ANNUAL BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2026**

WHEREAS, on March 23, 2026, by Roll Call No. 26-0347, the Municipal Housing Governing Board set the public hearing to consider the Municipal Housing Agency’s proposed amendment to the annual budget for fiscal year ending June 30, 2026, for April 6, 2026, at 4:45 p.m. in the Council Chambers in City Hall, 1200 Locust Street, Des Moines, Iowa, and public notice of such hearing has been published as provided by law in the Des Moines Register; and,

WHEREAS, those resident and taxpayers of the City or the area of operation of the Agency interested in the Municipal Housing Agency’s amended annual budget for the fiscal year ending June 30, 2026, have been given an opportunity to present to the Municipal Housing Governing Board objections to any part of the amended budget and arguments in favor of any part of the amended budget at this public hearing.

NOW, THEREFORE, BE IT RESOLVED, by the Municipal Housing Governing Board that:

1. The publication of notice for the hearing is hereby ratified.
2. Upon due consideration of all views and comments presented by residents and taxpayers of the City or the area of operation of the Agency, the public hearing on the Municipal Housing Agency’s amended annual budget for fiscal year ending June 30, 2026, is hereby closed.
3. The Municipal Housing Agency’s amended annual budget for the fiscal year ending June 30, 2026, as set forth in the operating budget document on file with the City Clerk is hereby approved and adopted.
4. The Mayor and the City Clerk are hereby directed to execute and certify the Municipal Housing Agency’s amended budget for the fiscal year ending June 30, 2026, to the Des Moines City Council for incorporation into the City’s fiscal year 2026 amended budget to be certified to the State of Iowa. **(Board Communication No. 26-125)**
