AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended, by amending Section 114-2883, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended, by amending Section 114-2883, relating to traffic and vehicle regulations, as follows:

**Sec. 114-2883. Southwest Thirty-third Street--Park Avenue to cul-de-sac south of ~~Stanton Avenue~~Gannett Avenue.**

~~Southwest Thirty-third Street, on the west side, from Park Avenue to a point 550 feet south of Wolcott Avenue and any part of the cul-de-sac, no parking any time.~~

~~Southwest Thirty-third Street, on the west side, from Stanton Avenue to a point 460 feet north of Stanton Avenue and any part of the cul-de-sac, no parking any time.~~

~~Southwest Thirty-third Street, on the west side, from Stanton Avenue to a point 570 feet south of Stanton Avenue and any part of the cul-de-sac, no parking any time.~~

Southwest Thirty-third Street, on the west side, from Park Avenue to and including the cul-de-sac south of Wolcott Avenue, no parking any time.

Southwest Thirty-third Street, on the west side, from and including the cul-de-sac north of Stanton Avenue to and including the cul-de-sac south of Stanton Avenue, no parking any time.

Southwest Thirty-third Street, on the west side, from Gannett Avenue to and including the cul-de-sac south of Gannett Avenue, no parking any time.

Southwest Thirty-third Street, on the east side, from Gannett Avenue to a point 70 feet south thereof, no parking anytime.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
