**RESOLUTION APPROVING ISSUANCE OF A CERTIFICATE OF COMPLETION
FOR UNION AT RIVERS EDGE
METRO CENTER URBAN RENEWAL PROJECT**

WHEREAS, the City and Union at Rivers Edge, LP (“Developer”) entered into an Urban Renewal Development Agreement (the “Agreement”), as authorized by the Des Moines City Council on January 23, 2023, by Roll Call No. 23-0103, for the construction of a 6-story building and a 3-story building at 1600 Indianola Avenue in Des Moines, containing a total of 216 dwelling units for affordable housing; and

WHEREAS, the terms of the Agreement provide that the City shall issue the Certificate of Completion upon the City’s determination of satisfactory completion of the development Improvements and the Developer’s request that the Certificate of Completion for the project be issued; and

WHEREAS, City staff inspected the development Improvements and found the Improvements have been completed in substantial compliance with the terms of the Agreement; and

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

1. The City Council hereby finds and acknowledges that Developer has satisfied its obligation to complete all Improvements in substantial compliance with the Agreement and the approved Conceptual Development Plan.
2. This resolution shall serve as the Certificate of Completion to be issued by the City pursuant to Section 2.7 of said Agreement.
3. The City Clerk is hereby directed to cause a certified copy of this resolution and roll call to be delivered to the Developer so that the Developer may record the resolution pursuant to the terms of the Development Agreement.
