AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended, by amending Section 114-3606, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended, by amending Section 114-3606, relating to traffic and vehicle regulations, as follows:

**Sec. 114-3606. Robertson Drive--Fifty-first Street to Fifty-sixth Street.**

Robertson Drive, on the south side, from Fifty-first Street to a point ~~225~~ 450 feet east of Fifty-sixth Street, no parking any time.

Robertson Drive, on the south side, from Fifty-sixth Street to a point 75 feet east thereof, no stopping or standing.

Robertson Drive, on the south side, from a point 75 feet east of Fifty-sixth Street to a point ~~70-150~~ feet east thereof, passenger loading and unloading 7:00 a.m. to 5:00 p.m. school days.

Robertson Drive, on the south side, from a point 225 feet east of Fifty-sixth Street to a point 110 feet east thereof, no parking any time.

~~Robertson Drive, on the south side, from a point 145 feet east of Fifty-sixth Street to a point 80 feet east thereof, bus loading and unloading 7:00 a.m. to 5:00 p.m. school days.~~

Robertson Drive, on the north side, from Fifty-first Street to Fifty-sixth Street, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
