**APPROVAL OF A GRANT AGREEMENT BETWEEN THE CITY OF DES MOINES,
IOWA AND THE MID-IOWA HEALTH FOUNDATION FOR THE CENTRAL IOWA
EMERGENCY RENTAL ASSISTANCE STUDY**

WHEREAS, the Mid-Iowa Health Foundation (the “Agency”) is a nonprofit corporation duly formed and existing pursuant to the law of the State of Iowa, with a mission to serve as a catalyst and partner to improve health outcomes among under-resourced populations in central Iowa; and

WHEREAS, the Agency is working with a research team at Grinnell College and social service nonprofits in Dallas, Polk, and Warren Counties to operate the Central Iowa Emergency Rental Assistance Study (the “Project”); and

WHEREAS, the City desires to provide financial assistance for the Project in the amount of \$50,000, to be paid within thirty (30) days of July 1, 2026, consistent with the terms of the Grant Agreement attached to this Resolution; and

WHEREAS, in return, the Agency will provide recommendations to the City regarding the most cost-effective strategies to achieve the outcome of housing stability for low-income households in the City experiencing crisis; and

WHEREAS, the City Council has reviewed the terms of the Grant Agreement and finds that it is in the public interest and serves important public purposes related to housing stability and the welfare of City residents.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, approves the Grant Agreement between the City and Mid-Iowa Health Foundation; the Mayor is authorized and directed to sign the Grant Agreement, the City Clerk is authorized and directed to attest to the Mayor’s signature, and the City Manager is directed to administer the Grant Agreement.
