APPROVAL TO SUBMIT AN APPLICATION TO THE DEPARTMENT OF JUSTICE FOR FUNDING OPPORTUNITIES: FY2026 INVITED TO APPLY- NATIONAL INTEGRATED BALLISTIC INFORMATION (NIBIN) MODERNIZATION PROGRAM; COMMUNITY POLICING SERVICES (COPS) MICROGRANTS; VIOLENCE AGAINST WOMEN FY2026 LOCAL LAW ENFORCEMENT GRANT FOR ENFORCEMENT OF CYBERCRIMES; COMMUNITY ORIENTED POLICING SERVICES LAW ENFORCEMENT MENTAL HEALTH AND WELLNESS (LEMHWA) PROGRAM; AND THE COMMUNITY ORIENTED POLICING SERVICES HIRING GRANT IN THE TOTAL AMOUNT OF \$7,750,000

WHEREAS the City of Des Moines will apply for funding from the Department of Justice for funding opportunities: FY2026 National Integrated Ballistic Information Network (NIBIN) Modernization Program; COPS microgrants; Violence Against Women: Law Enforcement Grant for Enforcement of Cybercrimes; COPS Law Enforcement Mental Health and Wellness Program; and COPS Hiring Program to be utilized in the purchase of law enforcement equipment, software and hiring additional police officers; and,

WHEREAS none of these grant opportunities require matching funds; and,

WHEREAS each opportunity has a defined performance period ranging from 24 months to 60 months; and

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the afore mentioned applications may be submitted to the Department of Justice with the Mayor authorized to sign the grant related documents on the behalf of the City, with the City Clerk to attest to the Mayor's signature and to allow the City Manager or his designee to submit and carry out the terms of each said grant application in a timely manner.
