**AUTHORIZING SUBMITTAL OF
FEDERAL SURFACE TRANSPORTATION BLOCK GRANT (STBG) PROGRAM AND
SURFACE TRANSPORTATION BLOCK GRANT SET-ASIDE PROGRAM
FISCAL YEAR (FY) 2030 AND FY 2031 APPLICATIONS TO THE
DES MOINES AREA METROPOLITAN PLANNING ORGANIZATION (MPO)**

WHEREAS, the City of Des Moines is a full member of the Des Moines Area Metropolitan Planning Organization (MPO); and

WHEREAS, the Federal Surface Transportation Block Grant (STBG) Program and Surface Transportation Block Grant Set-Aside Program STBG Program and the STBG Set-Aside Program Fund, formerly known as the Transportation Alternatives Program (TAP), provides funding to local jurisdictions for the construction of eligible projects; and

WHEREAS, the programs are administered by the MPO that prioritizes and ranks all project applications.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA, that the City Manager is hereby authorized to submit applications to the MPO for STBG and STBG Set-aside funds for the following projects:

STBG Project Applications:

1. Easton Boulevard - Fourmile Creek to E 56th Street
(Joint project with Polk County and City of Pleasant Hill)
2. SW 9th Street and Bancroft Street Roundabout
3. Beaver Avenue and Forest Avenue Roundabout
4. Fleur Drive Bridge over the Raccoon River Rehabilitation
5. East University Avenue Pedestrian Bridge over Fourmile Creek
(Joint project with Polk County and City of Pleasant Hill)
6. Intelligent Transportation Systems Upgrade
