ORDINANCE NO. _____

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended, by amending Sections 114-320.01, 114-2864, 114-3398, 114-3442, and 114-3526, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended, by amending Sections 114-320.01, 114-2864, 114-3398, 114-3442, and 114-3526, relating to traffic and vehicle regulations, as follows:

Sec. 114-320.01. Prohibited left turns.

No person shall make a left turn with a vehicle at the following locations:

- (1) At the intersection of East Euclid Avenue and Des Moines Freeway (Interstate Highway 235), prohibiting left turns from westbound East Euclid Avenue to southbound ramp, and prohibiting left turns from eastbound East Euclid Avenue to the northbound entrance ramp.
- (2) At the intersection of Sixth Avenue and Mercy Drive, prohibiting left turns from westbound Mercy Drive to southbound Sixth Avenue, between 3:00 p.m. and 6:00 p.m.
- (3) At the intersection of Forty-second Street and Des Moines Freeway (Interstate Highway 235), prohibiting left turns from southbound Forty-second Street to the eastbound entrance ramp.
- (4) At the intersection of Southwest Ninth Street and Tuttle Street, prohibiting left turns from the southbound service road of Southwest Ninth Street to Tuttle Street.
- (5) Not used.
- (6) At the intersection of Hickman Road and Sixty-first Street, prohibiting left turns from eastbound Hickman Road to northbound Sixty-first Street, between 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Monday through Saturday.
- (7) At the intersection of Fleur Drive and Iowa Highway 5, prohibiting left turns from southbound Fleur Drive to the eastbound Iowa 5 entrance ramp, and prohibiting left turns from northbound Fleur Drive to the westbound Iowa 5 entrance ramp.
- (8) At the intersection of Iowa Highway 28 and Iowa Highway 5, prohibiting left turns from southbound Iowa 28 to the eastbound Iowa 5 entrance ramp, and prohibiting left turns from northbound Iowa 28 to the westbound Iowa 5 entrance ramp.
- (9) At the intersection of Forty-first Street and University Avenue, prohibiting left turns and through movements from southbound Forty-first Street to and/or across University Avenue.

- (10) At the intersection of East Diehl Avenue and a private driveway 220 feet west of Southeast Fourteenth Street, prohibiting left turns northbound from the driveway to East Diehl Avenue.
- (11) At the intersection of Fifty-seventh Street and a private driveway 350 feet north of Douglas Avenue, prohibiting left turns eastbound from the driveway to Fifty-seventh Street.
- (12) At the intersection of Grand Avenue and a private driveway 500 feet west of 19th Street, prohibiting left turns northbound from the driveway to Grand Avenue.
- (13) At the intersection of Grand Avenue and a private driveway 1,140 feet west of 19th Street, prohibiting left turns northbound from the driveway to Grand Avenue.
- (14) At the intersection of Forty-second Street and Chamberlain Avenue, prohibiting left turns and through movements from eastbound Chamberlain Avenue to and/or across Forty-second Street.
- (15) At the intersection of Hull Avenue and Oxford Street, prohibiting left turns from eastbound Hull Avenue to northbound Oxford Street, between 2:00 p.m. and 4:00 p.m., school days.

Sec. 114-2864. Southeast Thirtieth Street--East Court Avenue to Brockway Drive.

Southeast Thirtieth Street, on both sides, from East Court Avenue to Vandalia Road, no parking any time.

Southeast Thirtieth Street, on the west side, from Hartford Avenue to East Watrous Avenue, no parking any time.

Southeast Thirtieth Street, on the west side, from East Titus Avenue to Easter Lake Drive, no parking any time.

Southeast Thirtieth Street, on the east side, from East Titus Avenue to a point 80 feet south thereof, no parking any time.

Southeast Thirtieth Street, on the east side, from a point 65 feet north of Easter Lake Drive to Easter Lake Drive, no parking any time.

Southeast Thirtieth Street, on the west side, from Easter Lake Drive to Hart Avenue, no parking any time.

Southeast Thirtieth Street, on the east side, from East Army Post Road to Brockway Drive, no parking any time.

Sec. 114-3398. Lay Street--Easton Boulevard to East Aurora Avenue.

Lay Street, on the west side, from Easton Boulevard to East Jefferson Avenue, no stopping or standing.

Lay Street, on the west side, from East Jefferson Avenue to Guthrie Avenue, no parking any time.

Lay Street, on the east side, from Easton Boulevard to East Washington Avenue, no stopping or standing.

Lay Street, on the east side, from a point 100 feet north of East Washington Avenue to a point 100 feet north thereof, school passenger loading and unloading 7:00 a.m. to 5:00 p.m. school days.

Lay Street, on the east side, from a point 200 feet north of East Washington Avenue to a point 75 feet north thereof, school bus loading and unloading 7:00 a.m. to 5:00 p.m. school days.

Lay Street, on the east side, from a point 275 feet north of East Washington Avenue to a point 125 feet north thereof, school passenger loading and unloading 7:00 a.m. to 5:00 p.m. school days.

Lay Street, on the east side from East Jefferson Avenue to a point 50 feet south thereof, no parking any time.

Lay Street, on the west side, from East Sheridan Avenue to a point 60 feet south thereof, no parking any time.

Lay Street, on the east side, from Arthur Avenue to East Sheridan Avenue, no parking any time.

Lay Street, on the east side, from Guthrie Avenue to a point 50 feet south thereof, no parking any time.

Lay Street, on the west side, from East Douglas Avenue to East Aurora Avenue, no parking any time.

Lay Street, on the east side, from East Douglas Avenue to a point 80 feet north thereof, no parking any time.

Lay Street, on the east side, from East Madison Avenue to a point 75 feet south thereof, no parking any time.

Sec. 114-3442. Luster Lane--Southwest Ninth Street to Southview Drive.

Luster Lane, on the north side, from Southwest Ninth Street to a point 50 feet west thereof, no parking any time.

Luster Lane, on the south side, from Southwest Ninth Street to Southview Drive, no parking at any time.

Luster Lane, on the north side, from a point 50 feet east of Southview Drive to Southview Drive, no parking any time.

Sec. 114-3526. Northwest Drive--Beaver Avenue to dead end west of Sixty-second Street.

Northwest Drive, on the south side, from Beaver Avenue to Forty-fourth Street, no parking any time.

Northwest Drive, on the north side, from Forty-first Street to a point 100 feet east thereof, no parking any time.

Northwest Drive, on the north side, from Forty-first Street to a point 50 feet west thereof, no parking any time.

Northwest Drive, on the north side, from Merle Hay Road to a point 50 feet west thereof, no parking any time.

Northwest Drive, on the south side, from Fifty-sixth Street to Fifty-seventh Place, no parking any time.

Northwest Drive, on the south side, from Merle Hay Road to a point 110 feet west of Sixty-second Street, no parking any time.

Northwest Drive, on the north side, from a point 50 feet east of Sixtieth Street to a point 50 feet west of Sixtieth Street, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
