APPROVING AGREEMENT WITH THE U.S. DEPARTMENT OF THE INTERIOR GEOLOGICAL SURVEY FOR THE OPERATION AND MAINTENANCE OF SIX (6) RIVER AND STREAM GAUGING STATIONS IN THE DES MOINES AREA

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached Agreement, in the amount of \$81,600 between the City of Des Moines and the U.S. Department of the Interior Geological Survey, which provides for the operation of the City's six (6) gauging stations, (63rd Street on Walnut Creek, Easton Boulevard on Four Mile Creek, Fleur Drive on the Raccoon River, 63rd Street on the Raccoon River, 2nd Avenue on the Des Moines River, and Van Meter on the Raccoon River), for which the City of Des Moines is obligated to pay \$59,840 and the U.S. Geological Survey will contribute \$21,760 to cover budgeted costs for the period from October 1, 2007, to September 30, 2008, be and is hereby approved, and the Mayor is authorized and directed to sign such Agreement and the City Clerk to attest to the Mayor's signature. The City of Des Moines has a separate 28E funding agreement with the City of West Des Moines and the Des Moines Water Works to proportionally share the City of Des Moines cost for certain gauges. Based on this 28E Agreement the City of Des Moines share of the \$59,840 will be \$36,720; and the City of Des Moines will invoice the City of West Des Moines for \$13,600 and the Des Moines Water Works for \$9,520.
