WHEREAS, in November 1906, under Polk County District Court Decree, Equity Case No. 14,666E, Petition of John G. Myerly et. al. ("Court Decree"), it was ordered that the North six feet of High Street as it extends through McCain Place from the West line of 28th Street to the East line of 31st Street should be and is vacated and shall revert to and become a part of the abutting lots and that the respective owners of such abutting lots and property are vested with title to such portion of the vacated parts of High Street as abut and are contiguous to such lots and property; and

WHEREAS, Chinh Dao is the current owner of 3024 High Street, which abuts a portion of the aforementioned vacated right-of-way; and

WHEREAS, due to a conveyance error by previous owners of Mr. Dao's property, the aforementioned vacated right-of-way was not properly conveyed to successive owners of 3024 High Street as required by the Court Decree, and this error has created a title defect on Mr. Dao's property that requires the issuance of a Quit Claim Deed from the City of Des Moines to clear such defect; and

WHEREAS, Chinh Dao has offered to the City of Des Moines the purchase price of \$1.00 plus closing costs in exchange for the Quit Claim Deed to such property more specifically described below; and

WHEREAS, on January 28, 2008, by Roll Call No. 08 -_____, it was duly resolved by the City Council that the proposed conveyance of the vacated East/West alley right-of-way abutting 3024 High Street be set down for hearing on February 11, 2008, at 5:00 p.m., in the City Council Chambers; and

WHEREAS, due notice of said proposal to convey this real property was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in this proposed conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.
