**Approval of a Development Agreement and Building Lease with
Mesaba Airlines, Inc. for Property at the Des Moines International Airport**

WHEREAS, the City of Des Moines, hereinafter called "City", owns an airport known as the Des Moines International Airport, located in Polk County, Iowa, hereinafter called the "Airport"; and

WHEREAS, on September 20, 1993, by Roll Call No. 93-3490, the Des Moines City Council approved Ordinance 12,040 assigning certain rights and responsibilities pertaining to the Airport to the Des Moines International Airport Board (hereinafter called the "Airport Board"), including the right to enter into leases of up to three years in duration and other certain agreements; and

WHEREAS, Airport staff and Mesaba Airlines representatives have been discussing a new maintenance facility to be constructed at the Airport; and

WHEREAS, Mesaba and the Airport have negotiated a Development Agreement and Building Lease ("Agreement") that includes provisions whereby Mesaba would contribute to the construction of and occupy a new maintenance facility valued at approximately \$12 million; and

WHEREAS, Airport staff and Mesaba have determined that an Agreement with a ten year term and a ten year option would be most appropriate to address both parties' needs; and

WHEREAS, the Agreement is greater than three years and therefore requires approval by Des Moines City Council; and

WHEREAS, on December 3, 2007, by Roll Call No. 07-2300, City Council set a date of public hearing on the proposal for December 17, 2007, and directed the City Clerk to publish notice of the proposal and the hearing; and

WHEREAS, pursuant to Sections 364.7 and 362.3 of the Code of Iowa, notice of the hearing on the proposed Development Agreement and Building Lease between the City of Des Moines and Mesaba Airlines, Inc. for property and other rights at the Des Moines International Airport was duly published on December 7, 2007, as provided by law; and

WHEREAS, on December 17, 2007, by Roll Call No. 07-2419, City Council continued the hearing to January 7, 2008; and

WHEREAS, on January 7, 2008, by Roll Call No. 08-072, City Council continued the hearing to February 11, 2008, and directed the City Clerk to again publish notice of the proposal and the hearing; and

WHEREAS, on February 5, 2008, by Resolution A08-037 the Des Moines International Airport Board recommended City Council approval of a Development Agreement and Building Lease with Mesaba Airlines, Inc.; and

WHEREAS, the notice of the hearing was published as directed and the public meeting and hearing has been duly held at the time and place provided for and in accordance with said notice, and those interested in said Agreement with Mesaba Airlines, Inc., both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council; and

WHEREAS, the City of Des Moines has determined that the Development and Lease Agreement would be advantageous and beneficial to the City; and

WHEREAS, the City Council deems it advisable to act favorably and finally upon said Agreement.

NOW THEREFORE BE IT RESOLVED, BY THE CITY COUNCIL OF DES MOINES, IOWA:

That the Development Agreement and Building Lease between the City of Des Moines and Mesaba Airlines, Inc. is approved and the Mayor is authorized to execute the Agreement with attestation by the City Clerk


