RESOLUTION AUTHORIZING AND APPROVING RELEASE OF EASEMENT FOR STORM SEWER RIGHT-OF-WAY FOR PROPERTY LOCATED IN THE VICINITY OF EAST 33RD STREET AND DUBUQUE AVENUE

WHEREAS, on January 28, 2008, by Roll Call No. 08-155, the City Council of the City of Des Moines, Iowa accepted real estate documents, including a storm sewer right-of-way easement ("replacement easement"), for property located in the vicinity of East 33rd Street and Dubuque Avenue from Habitat for Humanity, Inc. as part of the development process; and

WHEREAS, Habitat for Humanity, Inc. will be relocating the storm sewer on said property as a part of the development and has requested that the existing storm sewer right-of-way easement, as granted to the City of Des Moines and recorded in 1957 ("existing easement"), be released by the City of Des Moines and replaced with the replacement easement accepted by the City Council on January 28, 2008 as described above; and

WHEREAS, the City will have no need for the existing easement upon this specific property due to the acceptance of the replacement easement, and it is in the City's best interests to release said existing easement in exchange for acceptance of the replacement easement.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. There is no public need for the property interest described below and the public would not be inconvenienced by reason of the release of this Permanent Easement for Storm Sewer Right-of-Way specifically described as follows:

A 20 foot strip of ground across Lots 33 and 34, Block A, Gray Heights, the center line of said strip of ground being described as follows: Beginning at a point on the south line of said Lot 33, 16 feet East of the southwest corner thence on a straight line to a point on the easterly line of said Lot 34, 110 feet north of the southeast corner; also the North 20 feet of the South 55 feet of said Lot 34, Block A, Gray Heights, in the City of Des Moines, Polk County, Iowa.

As recorded in the Office of the Recorder of Polk County, Iowa on July 26, 1957, in Book 2970, Page 29.

- 2. The release of such property interest be and is hereby approved.
- 3. The Mayor is authorized and directed to sign the Release of Easement for Sanitary Sewer Right-Of-Way and the City Clerk is authorized and directed to attest to the Mayor's signature.
