## AUTHORIZING EXECUTION OF HOME DOCUMENTS WITH COMMUNITY HOMES, L.P. FOR RENOVATION OF LOW INCOME RENTAL HOUSING

WHEREAS, by Roll Call 08-002 on January 7, 2008, Roll Calls 07-2171, 07-2172 and 07-2173 on November 19, 2007 and a Roll Call TBD on March 10, 2008, the Governing Board of the Des Moines Municipal Housing Agency (DMMHA) has approved for sale to Community Housing Initiatives, Inc. (CHI) eighteen units of DMMHA owned housing;

WHEREAS CHI has formed Community Homes, L.P. an Iowa Limited Partnership to purchase the units from and renovate the housing units in order to utilize the allocation of Low Income Housing Tax Credits and Doug LaBounty is President of each entity (14 W 21<sup>st</sup> Street, Spencer, Iowa 51301);

WHEREAS, on November 6, 2006 by Roll Call No. 06-2243 the City Council supported an application for Low Income Housing Tax Credits for Community Housing L.P. to the Iowa Finance Authority and a preliminary commitment of HOME funds for \$250,000; and,

WHEREAS, the Low Income Housing Tax Credit application also contained an application for \$800,000 of State HOME funds to the Iowa Department of Economic Development; and

WHEREAS, the Community Homes, L.P. project was not originally provided an allocation of tax credits but was awarded an allocation upon appeal;

WHEREAS, the delay in approval of the Low Income Housing Tax Credit application resulted in a loss of the State HOME funds resulting in the City increasing the amount of City HOME funds to \$370,000; and

WHEREAS, the developer will repay all the HOME funds over a 16 year period; and

WHEREAS, the project will result in the continuation of scattered site rental units, recently rehabilitated, and affordable to persons at 40%, 50%, and 60% of median income; and
