APPROVAL OF PROCURMENT OF THREE REPLACEMENT AUTOMATED SIDE-LOADING
REFUSE TRUCKS FROM PETERBILT OF DES MOINES FOR GOOD CAUSE SHOWN AT A TOTAL
COST OF \$599,577.00

WHEREAS, on March 4, 2008, three (3) automated side-loading refuse trucks were destroyed by fire and now need immediate replacement to ensure residential refuse collection service levels by the Public Works Department Solid Waste Division; and

WHEREAS, Roll Call 07-468, dated March 12, 2007, approved the procurement of four (4) replacement side-loading refuse trucks from Peterbilt of Des Moines, 3445 Adventureland Drive West, Altoona, IA 50009, for use by the Public Works Department Solid Waste Division; and

WHEREAS, Peterbilt of Des Moines has agreed to supply the city with three (3) additional automated side-loading refuse trucks to replace those units destroyed by fire, at the original bid price of \$199,859.00 each, and

WHEREAS, the City Manager recommends that the procurement of three (3) replacement refuse trucks for use by the Solid Waste Division be exempted from the competitive bidding requirements for good cause shown, pursuant to Section 2-710(a) of the Municipal Code of the City of Des Moines; and

WHEREAS, funding is available from PWK100101/Solid Waste Enterprise Fund;

NOW THEREFORE BE IT RESOLVED, that good cause has been shown to exempt the procurement of three (3) replacement refuse trucks from the Procurement Ordinance competitive bidding requirements; and

BE IT FURTHER RESOLVED that the Des Moines City Council hereby accepts and approves the procurement of three (3) replacement refuse trucks for use by the Solid Waste Division from Peterbilt of Des Moines at a total cost of \$599,577.00.
