APPROVING EXECUTION OF THE SECOND AMENDED COOPERATIVE AGREEMENT
BETWEEN THE CITY OF DES MOINES, IOWA, AND THE
UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD)

WHEREAS, on September 8, 1987, by Roll Call No. 87-3813, the Des Moines City Council authorized the Des Moines Human Rights Commission to execute a Memorandum of Understanding with HUD, setting forth the terms and conditions by which the Commission processes housing discrimination complaints arising within the city limits of Des Moines, Iowa, in accordance with HUD's Fair Housing Assistance Program, and sends staff to mandatory training as required by HUD; and

WHEREAS, the City Council has approved similar agreements on an annual basis, including the Cooperative Agreement for FY2006 approved on May 22, 2006, by Roll Call No. 06-1058, and the Amended Cooperative Agreement approved on August 7, 2006, by Roll Call No. 06-1582; and

WHEREAS, this Second Amendment to the Cooperative Agreement provides an additional \$8,500.00 in training funds bringing the total amount for the FY2007 Cooperative agreement to \$29,100.00; and


WHEREAS, this Agreement must be returned to HUD following its approval by the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Amended FY 2007 Cooperative Agreement Number-FF207K077010 between the United States Department of Housing and Urban Development (HUD) and the City of Des Moines is hereby approved, and the Mayor is hereby authorized and directed to execute the Amended Cooperative Agreement on behalf of the City of Des Moines.

BE IT FURTHER RESOLVED that the Des Moines Human Rights Commission Director is hereby authorized and directed to submit the Amended Cooperative Agreement to the HUD office and to complete and submit any additional documents associated therewith.
