WHEREAS, the 1998 Quality Housing and Work Responsibility Act requires Housing Agencies to develop and submit to the U.S. Department of Housing and Urban Development (HUD) five year and one year Agency Plans; and

WHEREAS, the Agency Plans serve as operation, planning and management tools for the Des Moines Municipal Housing Agency (DMMHA), including a mission statement of the goals and objectives of the Agency to serve the needs of low and moderate income families; and

WHEREAS, the one year plan with an effective date of July 1, 2008 contains specific operational information including the Application for Capital Improvements grant; and

WHEREAS, the Public Housing Admissions and Continued Occupancy Policy, the Section 8 Administrative Plan, and the Family Self-Sufficiency Action Plan have been revised; and

WHEREAS, the plans were developed by City staff and the Public Housing Board during three working sessions open to the public, held on the following dates: November 28, 2007, December 19, 2007, and January 16, 2008; and

WHEREAS notice of the date and location of public hearings and the location of the availability of the "draft" plans was published in the Des Moines Register on January 31, 2008; and

WHEREAS, in January all Public Housing residents and Section 8 clients received notifications of the availability of the draft documents for their review and comment; and

WHEREAS City staff held meetings with the residents on the following date: February 14, 2008 at 10:00 a.m. and 3:00 p.m.; and

WHEREAS, the Director's Resident Advisory Board met on January 17, 2008 to review the Agency Plans; and

WHEREAS, at their meeting on March 19, 2008 the Public Housing Board held a formal public hearing to receive public comment on the Agency Plans and at the close of the public hearing, the Public Housing Board voted to approve the Agency Plans and recommend them to the Municipal Housing Governing Board for their approval and submission to HUD.
