WHEREAS, the subdivision plat entitled Easter Lake Estates Plat 4, located north of Easter Lake Drive in the area of SE 32nd Street, developed by the Legacy Group, represented by John Kline (officer), was approved by the City Council on June 22 , 1998, by Roll Call No 98-2013, and the City accepted Subdivision Bond No. IAC 25164 in the amount of \$103,891.00 from Merchants Bonding Company Mutual as surety for the estimated cost of completing the required public improvements and erosion control measures; and,

WHEREAS, on June 19, 2000, by Roll Call No. 00-1771, the City Council approved a reduction and partial release of such bond to the amount of \$25,973, in recognition of the partial completion of the required public improvements; and,

WHEREAS, the City Engineer and Community Development Director have certified that the required improvements have been satisfactorily completed and recommend that the remaining security in the amount of \$25,973 for such improvements be released and returned to the developer; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. That Sidewalk Bond No. IAC 25164 in the remaining amount of \$25,973 from Merchants Bonding Company accepted as Surety, is hereby released and shall be returned to the surety now that the improvements have been completed.
2. That the City Clerk be and is hereby directed to notify the Principal and Surety of the release of such security at the following respective addresses:
